To assist in your claim that you did not receive the citation in question, please provide the Court and the Prosecutor **with as much information and documentation as possible.**

Suggested documentation for **Defendant's True Identity Motion:**

1. Valid driver's license or Identification card.
2. Address information on the date the citation was issued.
3. Current address, home phone number, and work phone number.
4. Make, model, license plate number and proof of insurance of the vehicle operated on the offense date and current date (today).
5. Identity of person you know or have reason to believe has received and/or signed this citation using your name.
  - a. Name
  - b. Date of birth
  - c. Driver's license number
  - d. Home address and phone number
  - e. Work address and phone number
  - f. Make, model, and license plate number
6. Proof of your location on the date and time the citation(s) was issued. (Example: copy of work schedule, time slip, etc.)
7. Any other information or documentation you deem relevant to establish that you did not receive the citation in question.

**Note: A person commits a third-degree felony if he/she makes a false statement during or in connection with an official proceeding.**

**A person commits an offense if he/she makes, presents, or uses a record or document with knowledge that it is false.**
