Kingwood BOPA Event Scheduled

The city's Solid Waste Management Department will host a BOPA recycling event on Saturday, October 26 from 9:00 a.m. until 3:00 p.m. at the Kingwood Metro Park and Ride. This event is free and open to the public. Potential hazardous household items such as batteries, oil, paint and antifreeze will be collected.



- ACCEPTED ITEMS: Only residential
 waste (rechargeable household &
 automobile batteries, used motor oil and filters, cooking oil, LATEX
 paint, and antifreeze). Used motor oil will be limited to 5-gallons. All
 liquids are required to be in sealed, non-leaking containers. The
 original container with label is preferable. Repackaged items must
 be labeled as to contents.
- ITEMS NOT ACCEPTED: Business, medical, and agricultural waste will not be accepted. Oil-based paints, solvents, flammables, pesticides, herbicides and other similar hazardous materials will also not be accepted at this event.

Abatement of Dangerous Trees in Kingwood

The City of Houston announced the emergency abatement of six dangerous trees at 2007 Lake Village Drive in Kingwood's Trailwood Village neighborhood. City contractors removed these six trees on the private property on Friday and Saturday, August 16 and 17, 2013.



The dead and falling trees posed a hazard to residents, particularly for students who must walk by the property on their way to the nearby Foster Elementary School. Mayor Parker declared the abatement an emergency in order to have the trees removed before the start of the school year.



Space Center Blvd. Concrete Panel Replacement

The Space Center Boulevard concrete panel replacement project, managed by the city's Public Works and Engineering Department, began in late July and runs along Space Center Boulevard between El Dorado and Bay Area Boulevard. The work is used to repair severely cracked and broken sections of concrete streets. During this process, motorists will notice lane closures around the repair areas and are urged to drive cautiously through these active work zones.

Biggert-Waters Flood Act

The Bay Area Houston Economic Partnership recently hosted a meeting with political leaders in the region, including Council Member Martin, to discuss some things that can be done to improve/change the Biggert-Waters Act. Local leaders requested assistance from Congressional representatives in delaying the implementation of the act so that a study can be done on its economic impact on the Bay Area. The Councilmember is working closely with BAHEP to come up with a list of specific changes that need to be made to the act to reduce its negative effects on the Bay Area.

In July 2012, Congress passed the Biggert-Waters Reform Act which will extend the National Flood Insurance Program for five additional years. The act includes a number of key revisions that could negatively affect the Bay Area's home and business properties. Properties that are below the base flood elevation level, which has been raised by 5 feet with the revised act, will face significantly increased flood insurance rates. Even if a property was up to code at the time it was built, the owner will no longer receive

flood insurance discounts. Grandfathered rates and almost all subsidized rates are phased out in the new version of the Biggert-Waters Act. Therefore, houses built under older codes will now not meet the new flood guidelines. The Act also redraws the flood zone maps, classifying more properties as flood risks and placing more homes in the 100 year floodplain.

The act has several potentially serious consequences for homeowners in the Bay Area. Property values may fall for homes in the floodplain and owners could find it more difficult to sell their homes because of the higher insurance rates. Home vacancy rates might rise because the owners may not be able to afford the increased rates, and owners without mortgages may simply go without flood insurance.

These negative effects could potentially impact the Bay Area's economy greatly. Lower property values means decreased tax revenue which results in less money for schools and city services and infrastructure.

Sylvan Rodriguez Park Ribbon Cutting

On Tuesday, August 6 Council Member Martin in coordination with the Houston Parks and Recreation Department and Clear Lake Lacrosse Association held a ribbon cutting ceremony celebrating the new improvements that have been made at Sylvan Rodriguez Park in Clear Lake, worth \$1 million.



Since 2008, the Houston Parks and Recreation Department has been diligently working on implementing the start of a Long Range Master Plan, designed by Clark Condon and Associates and developed strongly by input received by park users. The completed construction, worth \$1 million, include a 155 car concrete parking lot with parking lot lights, new electric service and new sports field lighting on the existing fields, construction of a new multi-purpose field west of the two existing lacrosse fields, paved sidewalk connections between the parking lot and fields, planting and irrigation and detention.

In partnership with the Clear Lake Lacrosse Association, the Houston Parks Board will also be installing an electronic score board to the two existing lacrosse fields located on the west side of the park.

Council Member Martin thanks all the community members, the Houston Parks and Recreation Department and the Mayor's Office of Special Events for making the ribbon cutting such a success and encourages area residents to take advantage of the new improvements.

Landmark Shuttle Carrier Aircraft

Announcement

On August 22, Council Member Martin joined in the celebration as the Boeing Company, Space Center Houston and NASA Johnson Space Center collaborated in sponsoring an event at Ellington Field to announce a new achievement in the Shuttle Transport Project. The Landmark Shuttle Carrier Aircraft, which carried the actual space



shuttles to their permanent museum homes, will now be housed at Space Center Houston with an exact space shuttle replica mounted on top. The Boeing 747 Shuttle Carrier Aircraft has been a part of NASA's shuttle program for 30 years. Currently housed at Ellington Field, the historic aircraft will be transported to Space Center Houston in November. When the display is completed it will provide visitors a unique opportunity to take a realistic tour of both the shuttle carrier aircraft and the space shuttle replica. Space Center Houston is hoping that not only will this exhibit be a fascinating public attraction, it will also educate and encourage students to think about careers in engineering, technology, and science. The exhibit, entitled "The Shuttle and 747 Carrier" will be completed and open to the public in early 2015.

Texas Hurricane Conference

Vipulanandan from the University of Houston for the invitation to address conference attendees and give his testimony about his experience along the Gulf Coast as well as what the City of Houston does annually to prepare for hurricane season.

Tree Waste Month

As a friendly reminder, the city of Houston's Solid Waste Management will pick up "Tree Waste" during the month of September. "Tree Waste" is defined as "clean" wood waste such as tree limbs, branches, and stumps. Lumber, furniture, and treated wood will NOT be accepted.



Junk Waste may NOT be placed for collection during a Tree Waste month.

Tree Waste months are January, March, May, July, September, and November.

Placement Instructions:

- Tree Waste should be placed adjacent to the front curb in a location easily accessible to the collection vehicle between the hours of 6:00 p.m. the Friday before and 7:00 a.m. on the scheduled collection day.
- Tree Waste should not be stacked under low overhead electrical wires or other cabling, signs, or mailboxes; next to fences or posts; or on top of water meters, gas meters, fire hydrants, or other exposed utility components.
- Materials should not be placed in the street, on the sidewalk, or other right-of-way, or in any manner which would interfere with pedestrian or vehicular traffic.

 Tree Waste collection is limited to occupied residential units and vacant residential lots only if the waste generated is in connection with the maintenance of the property.

Restrictions:

- No more than eight cubic yards of Tree Waste may be placed at the curb for collection.
- The SWMD is not allowed to collect any material that was generated by contractors who were retained by a resident to perform work on his or her residential property. It is the responsibility of the contractor to remove all debris that may arise from the contractor's activities. These contractor-related activities include, but are not limited to: trimming and removal of trees, remodeling, new construction and roofing.
- If authorized items placed for collection are mixed with unauthorized items, department personnel shall not be obligated to sort the materials and may refuse the entire load.
- Solid Waste Management Department collection services are not available to multi-residential structures of more than eight units.

President/CEO Named for Houston Independent Crime Lab

The Houston Forensic Science LGC, Inc. announces the selection of Dr. Daniel Garner as its President and CEO. Dr. Garner brings a distinguished career of leading, building and improving forensic laboratories in both government and commercial environments.

Dr. Garner has most recently led the U.S. Department of Justice's efforts to improve forensic science activities in foreign countries. His work took him to more than thirty countries on five continents, where he conducted assessments of forensic laboratories, developed plans to improve their capabilities, and managed implementation of those plans.

Prior to his international work, Dr. Garner served as President of Cellmark Diagnostics, Inc., a leading commercial provider of DNA analysis services. Under Dr. Garner's leadership, Cellmark's lab became the first commercial laboratory to achieve accreditation by the American Society of Crime Laboratory Directors (ASCLD-LAB), while at the same time reducing turnaround times and operational costs.

Before his years at Cellmark, Dr. Garner managed the forensic laboratory for the Bureau of Alcohol, Tobacco and Firearms, where he similarly led their efforts to become the first federal laboratory to earn ASCLD-LAB accreditation.

The Houston Forensic Science LGC, Inc. was established by Mayor Annise Parker and the Houston City Council as an independent city-chartered organization to assume the operations of the current Houston Police Department Forensic Division. Dr. Garner's hiring follows a six-month international search led by Coleman, Lew and Associates.
