





TOTAL ATTENDANCE 16,527,615



Of the total \$56,393,375 impact reported to date, \$45,600,115 is attributed to 8 groups



Small/Midsize NPOs Impacted

Individual Artists

Artists consume materials to create the products for stage and stores that help drive Houston's creative economy and make our city a more enjoyable place to live and work. We need a much better understanding how the hurricane impacted this cohort of workers in order to retain them.

- Artists are among our most highly educated lower income residents
- They are less likely to seek public assistance than other populations
- They have strong networks and are a highly mobile workforce



The Harvey Arts Recovery group has two goals:

- 1. Advocacy: Ensure cultural sector is included in recovery--get every eligible organization and individual artists to apply for government support from FEMA and SBA
- 2. Support: Grants and funding for artists and NPOs

FEMA Public Assistance Grants

FEMA's Public Assistance (PA) grant program provides federal assistance to government organizations and certain private nonprofit (PNP) organizations

Through the program, FEMA provides supplemental federal disaster grant assistance for debris removal, life-saving emergency protective measures, and the repair, replacement, or restoration of disaster-damaged publicly-owned facilities, and the facilities of certain PNP organizations. The PA program also encourages protection of these damaged facilities from future events by providing assistance for hazard mitigation measures during the recovery process.
