The Human Resources Department is pleased to announce that the Employee Self Service system, ESS, is migrating to SAP, where most of our personnel data resides. The enhanced system will enable you to view and make changes to your information online instantly, instead of calling, faxing or delivering forms to the office. These enhanced actions will be done through the same convenient portal system you use today.

We're also working on a Manager Self Service system, MSS, which will give supervisors quick access to employee information, and provide a one-stop shop for a variety of personnel and organizational activities.

The ESS and MSS systems are powerful tools that enable you to do more independently. HR is excited about this initiative as we move from transactional to transformational. One of our primary objectives is to provide programs and services that make your work life easier. That's because you are at the center of all that we do.

The project will be rolled out in two phases - ESS is scheduled to be released in July and MSS will follow in September. Continue reading for more information on the exciting changes in store for you.

- Develop requirements for your positions
