# **GENERAL SUMMARY:**

In the Benefits Division of the Human Resources Department, performs as a lead in benefits and customer service duties in support of large departments/clusters and the Retiree Unit.

## **RESPONSIBILITIES:**

- Serves the benefits needs of the large departments/clusters such as the Police Department and Fire Department. Researches, analyzes, and resolves customer inquiries and concerns.
- Provides oral and written communications to employees, retirees, department liaisons, and health care vendors pertaining to City of Houston health benefits plans.
- Completes retiree paperwork and coordinates with Human Resources Information Management on retiree's status as they transition from active employees to retirees.
- Validates, maintains, and updates employee benefits information, and inputs data into SAP or the benefits enrollment site.
- Hosts and conducts benefits training for Houston Police Department and Houston Fire Department cadets.
  Ensures cadets have access to the benefits enrollment platform and responds to cadets inquiries regarding benefits enrollment.
- Maintains and updates Medicare vendor information in benefits enrollment platform and remains current on Medicare Plans.
- Prepares and verifies documents to adjust in the SAP HR and Payroll systems and maintains all health benefits records.
- Reconciles the health plan monthly eligibility reports and premium reports from medical and flexible plan companies.
- Reviews SAP configuration to ensure that employee benefits elections are validated and transmitted to the appropriate vendor.
- Enters and reviews entries into the employees'/retirees' eligibility updates in SAP, reconciliation, and discrepancy resolutions for vendor eligibility files, and administers all plans compliant with both contractual documents and applicable legislation.
- Assists in planning and participating as a facilitator for Open Enrollment.
- Performs other related duties as directed.

# **SPECIFICATIONS:**

#### KNOWLEDGE:
