

**NOTICE OF CITY OF HOUSTON, TEXAS, RUNOFF ELECTION TO FILL VACANCY, DISTRICT C,  
SATURDAY, MAY 16, 2026**

To the registered voters of the City of Houston, Texas:

**NOTICE IS HEREBY GIVEN** that the City of Houston, Texas (the “City”), will conduct a Runoff Election (the “Election”) as described herein, on Saturday, May 16, 2026, between the hours of 7 a.m. and 7p.m., at which there will be elected the following officer of the City to fill an unexpired term:

**Council Member, District C**

**Early Voting by Personal Appearance.** Early voting by personal appearance shall be held at the locations and during the periods as set forth below in Exhibit “A”, attached hereto and made a part of this Notice for all purposes, subject to such changes as may be necessary.

**Election Day Precincts and Polling Places.** The Election will be held within the precincts and polling places for the Election as established and designated by City ordinance and applicable Mayor’s Order, and as set forth in Exhibit “B,” attached hereto and made a part of this Notice for all purposes, subject to such changes as may be necessary. The polling places will be open from 7:00 a.m. to 7:00 p.m. on May 16, 2026.

**Persons Entitled to Vote.** Only voters of the City of Houston, Texas, who reside in Council District C, who are qualified under state and federal law, shall be allowed to vote at the Election.

**Early Voting by Mail.** Voters who are entitled by law to vote early by mail may obtain applications for early voting ballots to be voted by mail in accordance with the Texas Election Code by making application for a ballot by mail as follows:
