A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, January 26, 2021 with Mayor Pro Tem Davis Martin presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Tiffany Thomas, Greg Travis, Robert Gallegos, Karla Cisneros, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department and Marta Crinejo, Agenda Director present.

At 1:50 p.m. Mayor Pro Tem Dave Martin called the meeting to order and stated that Mayor Turner isn't present, he is on his way back because he attended a funeral this morning and one this afternoon.

Mayor Pro Tem Martin recognized Council Member Thomas for a presentation.

Council Member Thomas presented a proclamation to the School Board of Trustees to show appreciation for the work that the Alief ISD and HISD School Board has done for its students during School Board Appreciation Month and Darlene Breaux was presented the proclamation on behalf of the School Board of Trustees and Mayor Pro Tem Dave Martin on behalf of Mayor Turner proclaimed the month of January as School Board Appreciation Month in the City of Houston, Texas.

At 1:55 p.m. Mayor Pro Tem Martin recognized Council Member Jackson for the Invocation in which she invited her very own father Bishop Emanuel Jackson after which she led the Pledge of Allegiance.

Mayor Pro Tem Martin requested the Interim City Secretary to call the Roll

Mayor Pro Tem Martin stated that he wanted to review some of the procedures for conducting the Virtual Public Session. He is requesting for Council Members to speak slowly and clearly because this will help the City Secretary, the Close Captioner and the General Public. After Roll Call they established there was a Quorum. If by chance for example if they have to leave, just let them know on the Chat screen if they are leaving temporarily or if they are leaving for the duration because otherwise, they will assume that Council Members are present. If they are making the Motion or Seconding a Motion, they will need to state their name and their action clearly so they can have it down for the record. The Agenda Director will be monitoring the Chat and will provide him their names. Please don't use the Chat Room just for chatting. Mayor Pro Tem Martin stated to Ms. Gunter that there are a number of things they're doing at her park. Mayor Pro Tem Martin stated to Mr. Castillo that he had the opportunity to visit Delmar Stadium yesterday and he was there from 3:00 p.m. to about 5:30 p.m. when all the vaccinations were distributed. He thought the process at Delmar worked fantastically but the problem we are having at a lot of these satellite sites that Mr. Castillo brought up is that we don't have enough vaccines. We have 100 vaccines for some of our community centers that we're getting into in the predominantly African American and Hispanic Neighborhoods and then the site we have at Delmar Stadium today we have 1,000 doses and that happens today through Saturday. Mayor Pro Tem Martin invited him to take this offer to his State Representative and State Senator because they're the ones that receive the distribution from the Federal Government and then they are allocated to the City of Houston and for us we have more demand, then we have supply.

Pat J. Daniel, Interim City Secretary read the description or captions of the Items on the Agenda.

The Houston City Council reconvened at 9:00 a.m., Wednesday, January 27, 2021 with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Dave Martin, Tiffany Thomas, Greg Travis, Robert Gallegos, Karla Cisneros, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Arturo Michel, City Attorney Legal Department and Marta Crinejo, Agenda Director present.

At 9:00 a.m. Mayor Turner called the Meeting of this Houston City Council and requested the Interim City Secretary to call the roll.

MAYOR'S REPORT

Mayor Turner stated that in reference to the vaccine distribution, the City of Houston on Monday did open up another distribution site and this is at Delmar Stadium in District A and it's being run by UMMC which we have used on many occasions for the testing. They are providing the vaccines at that site and it is by appointment only, like the other sites and at Delmar they are doing about 1,000 a day, they are open Monday through Saturday from 8:30 a.m. to 5:30 p.m. and that's in addition to still using the Bayou Center which is also doing about 1,000 a day and there are several other clinics that we are using, Casa De Amigos, Sunnyside and in Sharpstown. This coming up Saturday we'll be out in the Alief Westwood Area providing vaccines, again this is by appointment only and this is in Council Member Thomas District. As the supplies ramps up, we will be able to expand additional sites because the goal is to have more community base sites, even some mobile sites and in some cases some people may be homebound and can't get to any of the sites, the Health Department will go to the individuals with shots at their home and that is the goal. We normally get distributions on Friday and for example last Friday we got 9,000 doses for the following week and so until those doses ramp up, the supply is certainly not going to meet the demand. He also wanted to say to the people that are listening the City of Houston is not the only Department receiving vaccines, the County is receiving the vaccines and the hospitals. The hospitals are receiving the greater percentage of these vaccines and then there are a number of other providers that the State has identified. Then we have got a list of potential venues that as the doses ramp up that we can immediately go to and that is where we are at this point. Mayor Turner was pleased to hear from the Biden Administration that they've purchased a couple hundred million doses, but you are talking about the summer. The people

with disabilities, they can call (832) 393-5500 and this is also for Seniors as well and they can be put on the waiting list if they utilize that number. His Office for People with Disabilities are working closely with the Houston Health Department's Aging and Disability Resource Center to ensure that people with disabilities and seniors have access to the vaccines as quickly as possible. With these vaccines he doesn't want people to lose sight of the fact that this virus is still very much present, and he encourages everyone to get tested.

In respect to the homeless count, every year in January we conduct these homeless counts, due to the pandemic many cities across the country have received federal approval to cancel their annual required homeless count, however the City of Houston believes that the information gained by doing the homeless count is invaluable and especially needed during these times. With that being said we are conducting our annual homeless count and survey but doing it a bit different because of COVID-19, we are still relying on community volunteers, we are exclusively utilizing more than 100 staff members from homeless agencies. Instead of lasting 3 days, HUD is allowing Houston count thru Friday January 29, 2021, which happens to be Mayor Turner's daughter's Birthday and lastly we are using new technology that will enable the count to be fully coordinated and conducted through an app. It will provide data from various counties enabling us to identify our hot spots and provide assistance in the implementation of the City and the County's Community COVID Housing Program. The data and professional analysis will be released by the Coalition for the Homeless in the second quarter of the year and if they want more information to please contact Marc Eichenbuam with my Office for Homeless Initiative.

The City of Houston has joined the National League of Cities 2021, Cities of Opportunity focused on equity and resilience. Houston will join six other cities across the Country, selectd for this action cohort intended to address power structures, policies and systems that block opportunities for Black, Indigenous and people of color and marginalized communities over generations and the City of Houston select to further the implementation of resilient Houston, specifically advise equitable investments in green stormwater infrastructure and nature based solution to combat flooding, urban heat, environmental in justice and to promote health well-being and economic opportunity. He is pleased that the Chief Resilience Officer Marissa Aho with Carol Haddock the Director Houston Public Works and Shannon Buggs will all be participating in this initiative.

Mayor Turner wanted to talk a little bit about the crimes in our City, the numbers are way too high as a carry over from 2020 and was not a good year for the City of Houston and it hasn't been good for many Cities in the United States but he wants to be specifically focused on the City of Houston. In addition, to what we are doing in law enforcements, he also wants to solicit the Council Members for their help because they know their Districts very well and they know the areas that can be hot spots. Mayor Turner wants to encourage the people in their District if they know something or they know people that are committing crimes, intend to commit crimes if they will make that information available. It's a community response and not just law enforcement response, it's going to take all of us to clamp down on this increase in crime.

Mayor Turner stated on a brighter note, he wanted to acknowledge Council Member Robinson; he has been offered and has accepted to be a Senior Warden in the Episcopal Church which is the highest honor you can receive based on his commitment and dedication to the Church.

Council Member Robinson congratulations and he knows how committed he is to his Church. Yesterday, he joined with the Consul General of India to celebrate their 72nd Public Day, Independence Day from the British rule that took place signing of the Constitution in 1950. So, to the Consul General of India to the 150,000 plus Indians that live in this City and region, he wanted to extend to them Happy Republic Day.

Mayor Turner stated since this is the last day Council Meeting before January 29, 2021, he wanted to use this forum to say Happy Birthday to his Daughter Ashley Paige Turner. He is looking forward to taking her to lunch and dinner. Happy Birthday Ashley Turner.

Members of Council commented and questioned Mayor Turner about the Mayor's Report.
