A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, October 18, 2022, with Mayor Sylvester Turner presiding with Council Members Amy Peck, Abbie Kamin, Carolyn Evans-Shabazz, Dave Martin, Tiffany Thomas, Mary Nan Huffman, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Mike Knox, David W. Robinson, Michael Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department and Marta Crinejo, Agenda Director, present. Council Member Tarsha Jackson absent on personal business.

At 1:40 p.m., Mayor Pro Tem Martin called the meeting to order and recognized Council Member Castex-Tatum for a first presentation.

MAYOR’S REPORT

Mayor Turner stated on yesterday, the first of its kind on recycling facility has been announced in the Houston area by Cyclyx, ExxonMobil and Lyondell Basell. the City of Houston has been working very closely with this group as well, with Solid Waste Department, Chief of the Economic Officer and others have been working. The \$100,000,000.00 facility will sort and process plastics, including many that are nonrecyclable with traditional recycling technology and this facility will have the capacity to process 150,000 tons of plastic. Creating fresh plastics from waste and serving as a pivotal piece of the circular economy. The City of Houston has partner with these groups and FCC Environmental Services and the Houston recycling collaboration with the goal of significantly increasing the plastics recycling rate here in Houston. They will be hearing more about it with the energy sector, the commercial sector and the City of Houston will announcing its own press statement in the next day or two (2).

Then yesterday the City of Houston was designated as a music friendly community from the State of Texas Music Office. He wants to give a lot of create to Nicole Irving, the music Friendly Community Program seeks to foster music business related to economic development in Texas Cities and communities. The Mayor's Office of Cultural Affairs completed the multistep certification process for this, with the support the Texas Music Office. The Music Industry in Texas created more than 210,000 direct and indirect permanent jobs. Mayor Turner wants to thank them for that.

Mayor Turner stating that the Health Department is encouraging everyone to get their flu shot. Of course, early voting beginnings Monday, October 24, 2022 and it runs through November 4, 2022. He wants to encourage everyone to exercise their democratic right to vote. The actual election will be on November 8th ,2022.

A shoot out to the Houston Dash, who ended their season after making the very first playoff debut. They had over 21,000 people in attendance for their match. Looking forward to seeing them in their next season.

Mayor Turner stated next will be a bi-week and some of them will be heading to the Japan trade mission. They will be leaving on Saturday with the Greater Houston Partnership and others business community. It will be a large trip because they are celebrating their 50th Sister City relationship with Chiba. Then, secondly the Houston ballet is also heading to Japan. So happens they are crossing at the same time. They will be performing "Swan Lake" while they are there.
