City Council Chamber, City Hall, Tuesday, February 18, 2003

A Regular Meeting of the Houston City Council was held at 1:30 p.m. Tuesday, February 18, 2003, with Mayor Lee P. Brown presiding and with Council Members Bruce Tatro, Carol M. Galloway, Mark Goldberg, Ada Edwards, Addie Wiseman, Mark Ellis, Bert Keller, Gabriel Vasquez, Carol Alvarado, Annise Parker, Gordon Quan, Shelly Sekula-Gibbs, M.D., Michael Berry and Carroll Robinson; Mr. Paul Bibler, Senior Assistant City Attorney; Mr. Richard Cantu, Director, Mayor's Citizens Assistance Office; Ms. Martha Stein, Agenda Director present.

At 2:01 p.m. Mayor Brown stated that Council would begin with the presentations with Council Members Alvarado and Edwards. Council Members Galloway, Keller, Vasquez, Parker, Sekula-Gibbs and Robinson absent.

Council Member Alvarado stated that she and Council Member Edwards were present to celebrate the 33rd anniversary of the SHAPE Community Center and invited Mr. Deloyd Parker to the podium. Council Member Edwards stated that for many the SHAPE Center was synonymous with community work, service and change and ground zero for activities regarding all issues of police brutality civil justice, education and health issues, etc. Council Member Alvarado stated that she and Council Member Edwards appreciated Mr. Parker and presented him with a proclamation for all he and the SHAPE Community Center had done. Mr. Parker thanked Council and stated that the SHAPE Center stood for peace and he was asking for a resolution in lieu of the proclamation, something to show that Council was against war and for peace. Council Members Vasquez and Robinson absent.

Council Member Galloway stated that she was honored to present a proclamation to a man who lived in the Pleasantville area many years and contributed much to the community and invited Mr. Talmadge Sharp and his family to the podium. Council Member Galloway stated that Black History Month was a celebration which promoted a spirit of harmony and cooperation and reminded all of the historical freedom in this country and presented Mr. Sharp with a proclamation for his many achievements and deep commitment to public service and proclaimed Tuesday, February 18, 2003, as "Talmadge Sharp Day", in Houston, Texas. Mr. Sharp thanked Council for the proclamation and stated that he had nothing but respect for city government and that the Pleasantville community had as much to do with this recognition as he did. Council Members Tatro, Vasquez and Robinson absent.

Council Member Quan stated that the key element in city growth was planning and that depended on knowing where everything was; that this was National Surveyors Week and invited Mr. Alan McLain, president of the Gulf Coast Chapter of Texas Society of Professional Surveyors to the podium. Council Member Quan presented Mr. McLain a proclamation for surveyors designing the cities, streets, etc., and proclaimed February 17 through February 23, 2003, as "Gulf Coast Chapter of Texas Society of Professional Surveyors Surveyor Week", in Houston, Texas. Mr. McLain stated that some of the most precious rights in this nation was freedom and the right to own land; that surveyors played an intrical part in those rights by establishing boundaries and accepted the proclamation on behalf of all surveyors. Council Members Vasquez and Robinson absent.

At 2:15 p.m. Mayor Brown called the meeting to order and Council Member Goldberg invited Rabbi Joseph Radinsky with the United Orthodox Synagogue to lead everyone in prayer and Council Member Goldberg led everyone in pledging allegiance to the flag. Council Members Vasquez and Robinson absent.

At 2:28 p.m. the City Secretary called the roll. Council Members Vasquez and Robinson absent.

Council Members Keller and Galloway moved that the minutes of the preceding meeting be adopted. All voting aye. Nays none. Council Members Vasquez and Robinson absent. MOTION ADOPTED.

Mayor Brown requested the City Secretary to call the list of speakers.

Council Member Edwards moved to suspend the rules to hear Mr. Andre Malveaux, Mr. Douglas Towne, Mr. Samuel Bynum, Mrs. Karen Jacobs, Ms. Ruth Terry, Ms. Kim Phillips and Mr. Andre Wells after Mr. James Baker, seconded by Council Member Ellis. All voting aye. Nays none. Council Members Vasquez, Quan and Robinson absent. MOTION 2003-0146 ADOPTED.

Mr. James Baker, 8484 Gulf Freeway, Houston, Texas 77017 (1-800-253-2690) appeared and stated that he had flown from Baltimore today on an issue he felt strongly about; that Council was responsible for providing the highest level of safety for firefighters and he had once been a firefighter and understood how critical it was to maintain their protective clothing and that was why he founded National Safety Clean, Inc., their clothing was their first line of defense and the contract, Agenda Item 43, dealt with care and maintenance of their protective clothing, but the individuals responsible for the bid award had ignored both industry standards and OSHA requirements as the competitor did not have facilities to insure no cross contamination and it did not provide for capture and containment of contaminates prior to wastewater entering the Houston sewer system and that was wrong; that his company had been the provider of the services since the Fire Department originally bid in 1999 and they clearly understood the issues; that they were also the only cleaning and repair company appointed to the National Fire Protection Association Standards Committee for the 1851 standard which was the standard for protective clothing maintenance adopted into law by the Texas Fire Commission; that his company was the low bidder but mysteriously it was awarded to their competitor as a bid item had been thrown out that vendors at the pre-bid were told would be part of the final evaluation. Council Members Galloway, Goldberg, Vasquez, Alvarado and Quan absent.

Council Member Ellis stated that he met with Mr. Baker, but did not know if he had the opportunity to review the letter passed to Council; that it seemed his competitor had a number of contracts with large fire departments and if his allegations were true he knew Council Members would want to halt the contract and evaluate it; and upon questions, Mr. Baker stated that it could be misleading to talk about departments you provided services for, one specific item said you must provide a department which you provided the same type of scope and concept program for so though they were large it could be misleading; that the biggest issue was the cross contamination issue and he would suggest they visit their facilities, but the facility used by his competitor was one large room with the contaminated garments going into the same room the cleaned garments were stored and that allowed for cross contamination which was a very serious concern. Council Members Galloway, Goldberg, Vasquez, Alvarado, Parker, Quan and Berry absent.

Mr. Andre Malveaux, 12611 Vitry Ln., Houston, Texas 77071 (713-885-0160) appeared and stated that he was present regarding the Chocolate Bayou Festival, March 1 and 2, 2003, which was an initiative brought to him by Council Member Edwards in an attempt to do something historically and culturally significant in the Sunnyside neighborhood and invited everyone to the festivity. Council Members Galloway, Goldberg, Vasquez, Alvarado, Parker and Quan absent.

Council Member Edwards thanked Mr. Malveaux for his assistance and expertise and all those who helped in contributing to the event. Council Members Galloway, Vasquez, Parker and Quan absent.

Mr. Douglas Towne, 9951 Twelve Way North #201, St. Petersburg, Florida 35716 (727-578-4440) appeared and stated that for the last few minutes he had heard about civil rights and community and there was no difference in new technology access questions for the disabled, it was a civil rights issue; that tomorrow at the committee meeting he would raise specific points, but they needed to know Mr. Lewis was making decisions based on a false premise which was

not his fault; that there was a document by Cisco which raised many questions and made many statements about accessibility and most were so outrageous and nonfactual that as of yesterday the company's attorney ordered it withdrawn and destroyed; and urged Council Members to think of this as a civil rights issue and step back and take another look at the subject of Voice Over IP in communications with people with disabilities, equal access. Council Members Galloway, Vasquez, Parker and Berry absent.

Council Member Sekula-Gibbs stated that last time he was present he brought to Council Members attention there was no legal requirement that Voice Over IP have any special consideration; that her office discussed it with Mr. Lewis and she discovered there had been no needs assessment done on the project and he said they would do that assessment after the contract was issued so it seemed the cart was placed before the horse and she would like to speak with him more tomorrow. Council Members Galloway, Vasquez, Parker and Berry absent.

Mayor Brown stated that as indicated tomorrow there would be a hearing on the subject or at least a briefing, at 2:00 p.m. before the TTI Committee and he could continue discussion on it at that time. Council Members Galloway, Vasquez, Parker and Berry absent.

Council Member Robinson stated that he and Council Member Sekula-Gibbs had asked for technical information about what it was technically each vendor was able to do now in terms of delivering equal access to the disabled community on their equipment so they could have a comparison. Council Members Galloway, Goldberg, Vasquez, Parker and Berry absent.

Mr. Samuel Bynum, 826 Richmond, Houston, Texas 77098 (713-666-7368) appeared and stated that he was an advocate for all disabilities and was present as a follow-up to what Mr. Towne said; that the disabled community could not standby and support the purchase of a system they could not use; that it was not a matter of what company or how much it cost they only wanted access, equal access. Council Members Galloway, Goldberg, Vasquez, Sekula-Gibbs, and Berry absent.

Mrs. Karen Jacobs, 14609 South Main, Houston, Texas 77035 (713-687-1411) appeared and stated that she was present once again asking Mayor Brown to direct the City of Houston Health Department director to issue their temporary food vendor permit with a 10 day grace period; that today was the last day to pay for their vendor permit and asked Mayor Brown to please help. Council Members Galloway, Goldberg, Sekula-Gibbs and Berry absent.

Mayor Brown stated that there was no lack of sympathy with the plight they found themselves in, they did conduct an audit and thought they had a resolution, but the Legal Department said it could not be done; and upon questions, Mr. Bibler stated that the matter had been researched and they could not do what was being asked. Mayor Brown stated that it would not help them this year, but they would continue to visit the matter and it might bring changes and help next year. Council Members Galloway, Goldberg, Sekula-Gibbs and Berry absent.

Council Member Ellis stated that if it was phrased where Council would come back and put a mandatory 10 day cap on permits, not charge for days 11 though the ending day; and Mr. Bibler stated that the ordinance needed to be enforced as written unless amended and this was the last day for permits so they could not grant them a grace period or fee reduction or give permits on credit. Council Members Galloway, Goldberg, Sekula-Gibbs and Berry absent.

Council Member Ellis moved to suspend the rules to hear from Ms. Gloria Moreno, seconded by Council Member Parker. All voting aye. Nays none. Council Members Galloway, Goldberg, Sekula-Gibbs and Berry absent. MOTION 2003-0147 ADOPTED.

Mayor Brown asked Ms. Moreno if there were anything in the rules that would allow day-

by-day payment on permits; and Ms. Moreno stated that the rule was that a permit should be purchased seven days in advance of the event, that time period gave them time to plan and get inspectors ready to go to the various sites; that normally people bought permits for the whole time period of the event, she was not aware whether they were bought piecemeal. Council Members Galloway, Goldberg, Sekula-Gibbs and Berry absent.

Upon questions by Council Member Vasquez, Ms. Moreno stated that fees were voted on in the budget process and she believed Mr. Bibler was saying they could not do what was being asked without modifying changes to the food ordinance. Council Members Galloway, Sekula-Gibbs and Berry absent.

Upon questions by Council Member Vasquez, Mr. Bibler stated that he recommended if Council Members had a concern they send the counters back out to check their work, but if there was nothing wrong he knew of no basis to change it and he did not know how they could say that it cost so much to send them out the first 10 days and cost less to send them out on days after that point so where would the rational basis be to do the last days free. Council Member Vasquez stated that he felt there was enough sentiment around Council to revisit the item and urged Council Member Ellis to take it up in the Regulatory Affairs Committee. Council Members Galloway, Sekula-Gibbs and Berry absent.

Upon questions by Council Member Edwards, Mr. Bibler stated that he hoped no one was talking of making exception and treating different groups differently, but that whatever they were going to do they would change the ordinance, but he had not heard of a way to do that without going back and asking the people who did the accounting analysis to look at it again; and he knew of no way to give people refunds constitutionally under Texas law. Council Members Galloway, Sekula-Gibbs and Berry absent.

Mayor Brown stated that they had asked the consulting firm to go back and look at their work but no report has come back as yet. Council Members Galloway, Sekula-Gibbs and Berry absent.

Council Member Robinson stated that he hoped departments would do a better job in letting people impacted by their actions know of what was happening; that all those regarding the food vendor permit who were coming to Council said they were not aware of what was going on with the fees and they should let people know of upcoming changes. Council Members Galloway, Sekula-Gibbs and Berry absent.

Mayor Brown asked Ms. Moreno if there was anything she knew of that would keep vendors from getting a seven day permit and then going back to get a permit for the rest of the days needed; and Ms. Moreno stated that she did not think that was impossible, but she did not run the program and she would check. Mayor Brown stated that if that was permissible they could get that seven day permit and earn the money to get the permit for the rest of the days needed; and Council Member Ellis would take the matter up in committee to see if they could come up with a permanent resolution. Council Members Galloway, Sekula-Gibbs and Berry absent.

Ms. Ruth Terry, 5908 Buffalo Speedway, Houston, Texas 77005 (713-665-6690) appeared and stated that she was happy with the suggestion made regarding the seven days and thanked Council Member Robinson for his suggestion stating if they had been aware of the fee changes they would have been more prepared and not so persistent in coming; and would still like an emergency meeting and have the fee possibly capped. Council Members Tatro, Galloway, Alvarado, Sekula-Gibbs and Berry absent.

Council Member Ellis stated that they were going to have an emergency meeting of Regulatory Affairs Friday. Council Members Tatro, Galloway, Alvarado, Sekula-Gibbs and Berry absent.

Ms. Kim Phillips, 819 Tassel, Houston, Texas, 77076 (no phone) appeared and stated that she would like to give her time to Ms. Karen Jacobs. Council Members Tatro, Galloway, Alvarado and Berry absent.

Council Member Robinson moved to allow Ms. Karen Jacobs to use Ms. Kim Phillips time, seconded by Council Member Vasquez. All voting aye. Nays none. Council Members Tatro, Alvarado and Berry absent. MOTION 2003-0148 ADOPTED.

Mrs. Karen Jacobs, 14609 South Main, Houston, Texas 77035 (713-687-1411) again appeared at the podium and stated that she appreciated the Mayor and Council taking so much time on their issue when they had such a long agenda; that she and the other vendors truly appreciated the conversation and discussion today as it made a difference, but she still could not see how it could cost the city \$14,400 a day to send inspectors to the rodeo. Council Members Tatro, Galloway, Edwards, Alvarado and Berry absent.

After further discussion by Council Members, Mr. Bibler stated that you could not issue a permit on credit, Council said the fee was to be paid in the Ordinance and the Constitution said they did not make loans; that if they were delinquent on the permit they did not receive the permit; that they were subject to what was in effect when buying the permit. Council Members Tatro, Galloway, Edwards, Alvarado and Berry absent.

Ms. Joann Schillaci, 710 E. Rogers, Houston, Texas 77037 (713-870-7300) had reserved time to speak but was not present when her name was called. Council Members Tatro, Galloway, Edwards, Alvarado and Berry absent.

Mr. Andre Wells, 16814 Fallen Leaf Way, Houston, Texas 77058 (281-282-9646) appeared and stated that he was present regarding illegal signage, abandoned signs, and the limited authority Mr. Norris and the Sign Administration investigators had; that it was his understanding nothing was being done to discourage the activity, but to just pickup the signs when complaints got heavy in one area or another; that it was not his objective to undermine the sign administrators, but to find a way to win the war and not just a battle or two; that legitimate businesses spent large sums of money to advertise only to be dishearten daily after seeing the same services getting the word out for free, the signs littered the community and as soon as they were removed by concerned citizens and city employees they were back out within the hour, they knew the system and knew it had no authority; that last year they brought attention to themselves with the insertion of razorblades in the corner of the signs and feces, grease and other unpleasant matter was spread on the backs to further deter there disturbance; that solution to the problem was attack at the source which was the number itself, signs did not work without a working phone number and if Mr. Norris had authority to research phone companies 99 times out of 100 he would have the perpetrator; and urged Council to be successful and empower the Sign Administrator with the ability to research phone numbers. Mayor Brown, Council Members Galloway, Edward, Alvarado and Berry absent. Mayor Pro Tem Quan presiding.

The City Secretary stated that under the rules of Council any outburst or applause was prohibited; and Council would appreciate observance of those rules during the meeting. Mayor Brown, Council Members Galloway, Edwards, Alvarado and Berry absent. Mayor Pro Tem Quan presiding.

Council Member Wiseman thanked Mr. Wells for coming with the issue again; that last time he appeared she had stated it was an issue not being dealt with appropriately and she and her staff had gone out collecting signs in Clear Lake; that the perpetrators were sabotaging their own signs to prohibit their removal and surely that in and of itself should be punishable by the city; and upon questions, Mr. Bibler stated that the most productive thing from his perspective would be to get with Mr. Norris, he thought he was generally familiar with who the characters

were that were doing it, but maybe he was not and it could be looked into. Mayor Brown, Council Members Galloway, Edwards, Alvarado and Berry absent. Mayor Pro Tem Quan presiding.

Council Member Wiseman moved to suspend the rules to hear from Mr. Norris of Sign Administration, seconded by Council Member Ellis. All voting aye. Nays none. Mayor Brown, Council Members Galloway, Edwards, Alvarado and Berry absent. Mayor Pro Tem Quan presiding. MOTION 2003-0149 ADOPTED.

Upon guestions by Council Member Wiseman, Mr. Norris stated that they did have a lot of means to find out who were placing the signs, many times the signs had addresses, a good number of them had phone numbers in phone books and were able to be found; that the ones hard to find were the ones with unlisted numbers, cell phone numbers and things of that nature: that last time the Mayor suggested he get with Chief McClelland which he did and he was given a liaison officer with HPD that could take the unlisted phone numbers and attempt to get the address of the particular violator and in those particular situations they had issued six citations: that one had gone to court and was dismissed because the inspector was seriously ill, the other five had not yet gone to court. Council Member Wiseman stated that she would like Council to see if they could implement changes through ordinances and have a more aggressive approach to offenders; that last year they picked up 167,000 bandit signs and wrote over 300 citations and that was only the official figures as many more signs had been picked up by others; that he was a part of a coalition studying the bandit sign problem, it was not just a local problem, and they were getting good ideas, but it seemed the ultimate solution would be to have individual citizens and business owners take part in the process. Council Member Wiseman stated that Council Member Parker was head of the Neighborhood Protection Committee and she would like to see if it was something they could look into and perhaps the coalition Mr. Norris was a part of could attend and share their findings. Mayor Brown, Council Members Galloway, Vasquez, Alvarado and Berry absent. Mayor Pro Tem Quan presiding.

Council Member Parker stated that was one of her pet issues as well; that they had augmented the city's work by getting many volunteers and clearly they were fighting a losing battle; that she would remind Council Members some of the largest offenders were realtors and builders many of whom were on their campaign contributors list and they should speak with them; and upon questions, Mr. Norris stated that each zone inspector covered over 80 square miles and they were stretched thin. Council Member Parker stated that her office had been wanting to jump in on the issue and she appreciated that he would be attending the committee meeting. Mayor Brown, Council Members Galloway, Vasquez, Alvarado, Berry and Robinson absent. Mayor Pro Tem Quan presiding.

Upon questions by Council Member Wiseman, Mr. Norris stated that regarding the signs with razorblades, etc., they filed a report with the Police Department and they investigated the best they could, some were being fingerprinted. Council Member Wiseman stated that she would like Chief Bradford to have someone visit with her to see exactly what was being done with respect to taking action on the razorblades. Mayor Brown, Council Members Galloway, Keller, Vasquez, Berry and Robinson absent. Mayor Pro Tem Quan presiding.

Council Member Goldberg stated that he called the number on a sign as they had many out and within an hour they were pulled up; and Mr. Norris stated that many times someone went in business and thought it was legal and they would go pull them up; and many times his office did call them, they were pulled up and never saw any more from that particular company; that the individual Mr. Wells spoke of knew how to play the system and every time he got a new cell phone he had a new batch of signs and he also moved around and was hard to find. Mayor Brown, Council Members Galloway, Keller, Vasquez, Berry and Robinson absent. Mayor Pro Tem Quan presiding.

Council Member Sekula-Gibbs stated that the city posted names of those who did not pay

taxes and it seemed fair the offenders names be posted also; and Mr. Norris stated that had been discussed. Mayor Brown, Council Members Galloway, Edwards and Berry absent. Mayor Pro Tem Quan presiding.

Mayor Pro Tem Quan stated that regarding the food vendor issue the Health Department had contacted them and they were willing to issue a 10-day permit and would wait until Thursday; and upon questions, Ms. Moreno stated that they would issue a 10-day permit and give vendors two days to get into the office and do the paperwork so by Thursday they should all be in and then pending a resolution by Council they would then need to go back and pay the balance or get the permit without a balance depending on Council's actions. Mayor Brown, Council Members Galloway, Goldberg, Edwards and Berry absent. Mayor Pro Tem Quan presiding.

Council Member Vasquez moved to suspend the rules to hear Mr. Frank Pugliese and Mr. Josh Bullard after Dr. Selina Ahmed, seconded by Council Member Tatro. All voting aye. Nays none. Mayor Brown, Council Members Galloway, Goldberg, Edwards and Berry absent. Mayor Pro Tem Quan presiding. MOTION 2003-0150 ADOPTED

Dr. Selina Ahmed, 10010 Kirkaspen Dr., Houston, Texas 77089 (713-313-7636) appeared and voiced her personal concerns and opinions against the war in Iraq and stated that her and her families faces were added to racial profiles; and urged Council to pass a resolution opposing the Iraq war. Mayor Brown, Council Members Galloway, Goldberg, Edwards and Berry absent. Mayor Pro Tem Quan presiding.

Mayor Pro Tem Quan stated that he introduced a resolution asking Council Members to support the United Nations inspectors and hoped to have it on the Agenda this week; that he would encourage everyone to encourage their Council Members to take that position. Mayor Brown, Council Members Galloway, Goldberg, Wiseman, Ellis and Berry absent. Mayor Pro Tem Quan presiding.

Mr. Josh Bullard, 2600 Westridge #237, Houston, Texas 77054 (713-839-1505) appeared and stated that he spoke with the Harris County Commissioners Court January 21st for three minutes and when the meeting was over he saw the Harris County Attorney speaking with the City of Houston municipal channel person and thought nothing of it, but later he saw his segment was sliced out. Mayor Brown, Council Members Galloway, Goldberg, Wiseman, Ellis, Parker and Berry absent. Mayor Pro Tem Quan presiding.

Mr. Frank Pugliese, 4633 Wild indigo #525, Houston, Texas 77027 (713-818-0104) appeared and stated that his issue referred to Houston streets, a week ago today he was driving someone to their home, 2116 Main, and driving east on Pierce he came to a red light at Pierce and Main; that Main was closed with barricades in both directions and he followed his friends advise to just go through the light as no one stopped because the street was closed, but he received a ticket for doing so and it cost \$175.00; that was his mistake and he accepted it, but his recommendation was when streets were completely closed why could not the red traffic light be changed to a red blinking light so people would pull up, stop and go. Mayor Brown, Council Members Galloway, Goldberg, Wiseman, Ellis, Parker and Berry absent. Mayor Pro Tem Quan presiding.

Mayor Pro Tem Quan stated that they had been looking into the issue and it would be taken under advisement. Mayor Brown, Council Members Galloway, Goldberg, Wiseman, Ellis, Parker and Berry absent. Mayor Pro Tem Quan presiding.

Council Member Alvarado stated that she would protest the ticket, she could not see why it was issued in the first place; that she saw people go through such lights all the time and also thought it should be changed to a flashing red light. Mayor Brown, Council Members Galloway, Goldberg, Wiseman, Ellis and Berry absent. Mayor Pro Tem Quan presiding.

Mr. Jason Heidelberg, 715 Welch, Houston, Texas 77006 (832-643-4207) appeared and voiced his personal concerns and opinions against a war with Iraq, stated that he was a veteran of the U. S. Air Force and defended this country in Operation Northern Watch and Operation Seven Watch, enforcing UN sanctions on the nation of Iraq; and urged Council Members to bring forth a resolution for peace and allow the United Nations to work. Mayor Brown, Council Members Galloway, Goldberg, Wiseman, Ellis and Berry absent. Mayor Pro Tem Quan presiding.

Mayor Pro Tem Quan thanked Mr. Heidelberg for serving our country and for coming to Council and voicing his opinions. Mayor Brown, Council Members Galloway, Goldberg, Wiseman, Ellis and Berry absent. Mayor Pro Tem Quan presiding.

Upon questions by Council Member Edwards, Mr. Heidelberg stated that he was 27 years old; that when he went to Operation Seven Watch in Saudi Arabia he was 20 years old and when he went to Operation Northern Watch he was 22 years old; that many experience effects from war including mental trauma. Council Member Edwards stated that she would suggest to those who had not served in war to have the courage and conviction to talk before sending others. Mayor Brown, Council Members Galloway, Goldberg, Wiseman, Ellis and Berry absent. Mayor Pro Tem Quan presiding.

S. Navy and had gone to Korea, Vietnam and Taiwan; and urged Council Members to at least take the item up for debate and then stand up and be counted. Council Member Parker thanked Mr. Cunningham for coming and stated that few politicians willingly walk into a political buzz saw which apparently this had become; that she wondered if he was aware that some state legislatures and congressional representatives had indicated there might be a financial impact on this city if they voted for Council Member Quan's resolution. Mr. Cunningham stated that he was not aware of that, but regardless, if they were present he would say the same to them because he considered it his sworn duty to do so as someone who had many times taken the oath to uphold and defend the United States. Council Member Parker stated that she had taken it a few times as well and would certainly standup and be counted if she is allowed the opportunity. Upon questions by Mayor Pro Tem Quan, Mr. Cunningham stated that Mayor Pro Tem Quan's resolution did not read no war ever, as he read the draft it said let's not blow the whistle before the game was over; that the inspection process should be allowed to continue until its conclusion; and he felt if the U. S. went on with a preempted strike they would lose a great deal of respect around the world and receive an extremely strong negative reaction in many parts of the world. Dallas #520, Houston, Texas 77019 (713-807-7831) appeared and voiced his personal opinions and concerns against war with Iraq; and stated that the resolution was primarily asking the Administration to stay course with regard to the inspections and be a part of the community of the world. Council Member Robinson stated that he would like to meet with Rev. Bode and he did not want a debate or disagreement, but his observation was they used the word unilateral and that did not reflect the reality of the circumstance because the United States was not acting unilateral as there was a 15/0 vote on the security council and there were nations signed on; that stay the course and remain a member of the world community was clearer; that they should

Mr. Douglas McIntyre, 18147 Dinner Creek Dr., Katy, Texas 77449 (no phone) appeared, presented information and stated that that today in the City of Houston he and cabdrivers, about 25, present with him had been losing income because of a rule Council passed which was that there should be no solicitation of business at hotels, Chapter 40, Section 46 and in the same section it said certain companies could go to the hotel, pay money and have exclusive business and as of last week five hotels excluded cabdrivers because they worked for the wrong company and they felt it was a direct violation of civil rights; that the city had licensed the drivers and given them the right to work and yet they were not able to go to hotels and stand in a public cabstand; and they were asking for Council to go back and revisit the ordinance and if any cabstand was allowed at a hotel they asked that it be done on a first come, first serve basis so no drivers were prohibited. Council Member Wiseman stated that her having been out it would be her first time seeing the item and she did, technically, have the ability to tag the item, that she did receive a memo though from the Agenda Director saying that to do so would put the item at high risk with respect to the fleet purchase itself, that she wanted the opportunity to have additional questions answered with respect to this item and the other item on vehicle purchases, that she had asked for information on justification, the justification that they received was, while maybe appropriate at other times, she did not think was appropriate now given that they were facing tough budget times, that the justification was nothing more than a shopping list in her opinion, that they had been told that a lot of these vehicles were replacement vehicles, but what she wanted to know was, had steps been taken to totally cut back on what was needed, that she did not think that they should just be accepting a shopping list and going with that, so given that she was concerned about the fact that the justification did not come in the way of, we absolutely need these vehicles or inspections would not be made, we absolutely need these vehicles or the Police Department would not be able to go out and do their investigations, that given that she should could not tag the item, she would be voting against the item.

Council Member Tatro stated that Council Member Wiseman brought up some good points, that his concern was that like zero based budgeting they asked that the budget be proved and they ask that the number of vehicles they were purchasing be proved and thought what they had fallen into was the standard operating procedures saying that they had a policy which said they refurbish their vehicles every three years or every 60,000 or 70,000 miles so therefore they needed to purchase more vehicles to replace those because that was their policy, that he thought they had gotten into a rut and did not think they had proven the zero based budgeting aspect of proving that they needed these vehicles and with the respect of the budget tightening and going back and either revamping the policy or not just following the policy and actually looking at the life of the vehicles and making the tough decision about which vehicles needed to be replaced and which vehicles did not need to be replaced, that he would be joining Council Member Wiseman as a no vote on the two items.

Mayor Brown stated that the item did not pass and wanted to point out that it had some very serious consequences for doing the business of the City and in the long run was going to cost the City more money, that he thought it was a very unwise vote that they had taken today and indeed surprising and asked Mr. Haines to address the consequences.

Mr. Haines stated that he could address the consequence and asked that Dr. Scheps speak to it also, but essentially what it meant that they had to go back out and re-bid the whole deal, that what was before Council was an authorization on a unit price basis to acquire vehicles, it did not mean, as he presented as Fiscal Affairs and as Ms. Sara Culbreth presented at Fiscal Affairs, it meant that it was a 100% procurement decision, they had committed as they stated at Fiscal Affairs, they had completed their zero basing of the take home program and were in the process of zero basing the light utility vehicle fleet management program and intended to make that report back to Council through the Fiscal Affairs Committee beginning at the next meeting, that again he thought that the problem was that it was a specific bid process that identified unit pricing and clearly they would simply have to go out, that the problem was that they had a fleet some of which they had to replace and it included several pieces of rolling stock that frankly they were going to have to deal with, that he asked that Dr. Scheps speak to the fiscal impact.

Mayor Brown stated that for those who wanted to save the City money, they were costing the taxpayers money on this one.

Dr. Scheps stated that they were very cognizant of the budget problems when they went through the fleet replacement process and they did not replace any sedans whatsoever, they simply put a moratorium on sedans, with the exception of emergency vehicles for the Police Department, they set the criteria very high and evaluated that so they were not getting any new vehicles at all, except for a couple at the Airport where there was a new fire station going in, new security vehicles, so he felt like they were extremely judicious in their use of this, only about \$600,000 of it was General Fund money, incidentally and guessed everybody understood that, that they were big RCA's, but only \$600,000 for the police investigative sedans was the only General Fund money and four trucks for the Public Works Department with high mileage, that he felt that they were very well aware of the budget pressures when they went through the process.

Upon questions by Council Members, Dr. Scheps stated that it was not that the prices were going to be more expensive in six months, that it was that these were very old vehicles and he was assuming that the maintenance on them, and in the aggregate it cost more to maintain the 120,000 miles and 130,000 miles sedan than to purchase new ones on a time payment plan, that it was not a reverse auction, but a standard process where they go out on written bids like they had for years, and to Council Member Wiseman, he was unaware that she had asked for any additional justification and did not know what that was about, they scheduled it for Fiscal Affairs two weeks ago so they could get those inputs and was not aware that she needed anything else, that he wanted to get her what she needed and all her questions were good and thought they had answers.

Council Member Tatro asked for a point of order and stated that he would like to move the agenda, and Mayor Brown asked the City Secretary to call the next item.

Council Member Edwards stated that she did not want to tag the item, but did need to talk to some one regarding the report that was on the television last night regarding the State investigating the Crime Lab and what that meant, and Council Member Alvarado stated that her office had been in contact with State Representative Kevin Bailey and evidently it was not just happening in Houston, there were other Crime Labs throughout the State, even discussions about the FBI's Crime Lab that was not up to par, so they were going to conduct some hearings very similar to Congressional hearings, on the overall issue of Crime Labs, and Council Member Edwards stated that she wanted to know what were the ramifications or implications for their department and what that meant, and Mayor Brown stated that he would have some one come by and answer her questions. Council Member Tatro absent.

Council Member Robinson stated that it may be worth their effort to have Chief Bradford stop by and give them a briefing, that he had an opportunity to meet with him yesterday and knew he had several things working in the area to respond, that he appreciated him bringing him up to speed because the item was on the agenda, that he was going to be supporting it and looked forward to working on his effort, that he also supported Representative Bailey's effort because one of the things they all made a commitment to, whether or not they were for or against the death penalty, was that DNA was one of the ways that they could help to sort out with a greater degree of certitude whether or not somebody was guilty of a crime and if they had questions about the competency of the Crime Labs around the State it brought serious issues of concern to the forefront on it and hoped that there would be some legislation that talked about standardization and level of certification and those sort of things to make sure when they went into court with DNA it was the best that they could have under any and all circumstances. Council Member Tatro absent.

Council Member Tatro absent.

Mayor Brown stated that they would have someone from Public Works visit with him, but briefly, the agreement did not cover the utilities, the City paid 100% of that and they see the cost a little higher as a result of that. Council Member Tatro absent.

Council Member Galloway stated that she was excited to see the particular item on the agenda and wanted to thank the administration and everyone for working with TXDOT to get the item moving, because the Pleasantville Community as well as one of their major tax base, Anheuser-Bush Company, had been wanting the street reconstructed for over 4 or 5 years and it was finally coming to fruition so she was very excited about it and encouraged her colleagues to support the item. Council Member Tatro absent.

Almeda a few weeks ago and had something on Clay Street and it was beginning to happen all over and if they had to pay \$3 million for it every time they were going to lose money that could go to neighborhood street reconstruction, and Mayor Brown stated that they would have someone come and meet with him on it. Council Members Tatro and Robinson absent.

Council Member Galloway stated that she was certainly glad that her colleague, Council Member Goldberg, was looking at the issue because it was what she had been stressing for quite some time in the district she represented, about the infrastructure and hoped she could certainly get his support when the budget came up for them to do a whole neighborhood to upgrade those neighborhoods, because her infrastructure was approximately 50 or 60 years old. MATTERS TO BE PRESENTED BY COUNCIL MEMBERS

Council Member Sekula-Gibbs stated that she was surprised to hear on the television that the Police Department, in some fashion, had reduced helicopter coverage and would like for someone from the Police Department to either brief the whole Council or at least brief her on why that happened after Chief Bradford told them that he was not going to do it, and Mayor Brown stated that it had not happened yet, but was one of the items they were looking at in terms of scaling back their expenditures to meet budget, that it was on the table, and Council Member Sekula-Gibbs stated that she would like to speak against reducing their helicopter service and actually expanding it. Council Members Tatro, Goldberg and Robinson absent.

Council Member Sekula-Gibbs stated that she had spoken with Mr. John Bales yesterday about a summit that was occurring in Washington, D.C. on March 3 through 5, 2003 and would be an understanding of allocation opportunities from the Home Land Security Bill, that Mr. Bales was very interested in attending that and was considering it and the Mayor was probably aware of it, but the issue was very big, that the Home Land Security Bill contained \$4.5 billion, that in this case they did need to send representatives to Washington to understand how the \$4.5 billion was going to be allocated, that she thought they must send representation, whether it was directly from the Police Department or Health Department or if Mr. Bales could do the whole job, but she thought it was critical that they were present at the Washington summit, that she would like to meet with Mr. Bales and Chief Bradford on the helicopter issue. Council Members Tatro, Goldberg and Robinson absent.

Council Member Parker stated that in reference to the helicopter issue, Council Members would recall that the Chief simply came to committee and laid out four areas where he thought the department could safely and reasonably cut expenses and one of those areas was the helicopter division and she would respectfully disagree with her colleague, that they had one of the largest helicopter fleets of any City in the Country and thought they could safely reduce it by half and still meet their requirements for inspection of water lines and so forth. Council Members Tatro, Goldberg and Robinson absent.

Council Member Parker stated that the only item she had was the item on Channel 13 last night about delinquent library fees and would like the administration to follow through and visit with her on that. Council Members Tatro, Goldberg and Robinson absent.

Council Member Alvarado stated that she too wanted to comment on Council Member Sekula-Gibbs remarks regarding the helicopters, that she did not think if they had a bio terrorist situation that those helicopters would be affected, she believed they were talking about the ones that did the routine flights around the City, that they flew out every couple of hours. Council Members Tatro, Goldberg and Robinson absent.

Council Member Alvarado stated that they had a speaker at Council yesterday to complain about getting a ticket for passing a red light on the street crossing Main, that was blocked, that she wanted to reiterate that she thought it was ridiculous, that she knew they needed all the revenues they could get, but ticketing someone for passing a street that was shut down did not make any sense, that she thought they wanted to make sure that they did everything to make downtown a place where people wanted to come and visit, it certainly deterred people from coming downtown, so she hoped that HPD and Public Works would get to work on that.

Council Member Alvarado stated that she wanted to congratulate the Port of Houston, last week they received their coffee designation, that as they knew it had been a very long process and started with Senator Gallegos and Representative Joe Moreno introducing legislation to allow for the Port to be considered as a Coffee Port Designation and also took the passing of a Constitutional Amendment, which was not very easy to do, it happened every once so often in their State, so she wanted to congratulate the Port on getting that designation from the New York Port of Trade. Council Members Tatro, Goldberg and Robinson absent.

Council Member Alvarado stated that she lost a bet last night to a friend of hers who was on the City Council in Los Angeles, that they were betting on the Rocket and Laker game, so if they saw her walking around in Laker gear, that was why. Council Members Tatro, Goldberg and Robinson absent.

Council Member Berry stated that he wanted to commend the administration on working with TXDOT to get Spur 527 closure postponed, because he thought that was a train wreck waiting to happen, that he and Council Member Parker went to more than a few meetings in the community and knew there was a lot of concern, particularly that it was going to happen at the same time that 610, between Hwy 59 and I-10 was going to be closed, that he did not know who

in the administration led that but would like to commend them. Council Members Tatro, Goldberg and Robinson absent.

Council Member Berry stated to follow up the issue on the library fines that Channel 13 carried the other day, the \$9.6 million in overdue library fines, that it concerned him quite a bit, that Ms. Brenda Tirrell in the library did not seem terribly concerned with the problem and suggested that it was just the cost of doing business, that they had seen a pattern throughout the City in how they collect fees, or better yet do not, and that was that they provide ambulance services and were just not going to worry about how they collected it, they were not going to collect on the Municipal Court fees and not going to collect on their Property Tax fees and at some point they were leaving millions of dollars and it was adding up to close to \$100 million in uncollected fees and fines over all the departments and thought it was a real problem, that it was also reported, and they verified it with several people, that if they owed fines and fees they were not receiving the notices of overdue fines, that the library stated that they were sending out two notices and they could not find anyone who had ever received one of the notices, and Council Member Parker stated that she had received a notice, and Mayor Brown stated that he had seen them so it was just not true, and Council Member Berry stated that it was not true if he had seen one in that case, but more than a few people that had overdue fines told them that they never received anything, that a typical amount owed, according to Channel 13, was \$20 to \$30, but they had individuals owning \$5,000, one of whom checked out 235 books, that he thought they needed to put in place some solutions and he had a few thoughts, that first of all that they send out regular notices, so he would like to see from the library the program they had for mailing them out and their initial request was not met with a lot of excitement, so he was a little disappointed there, that the second thing, was to publish the names of those owing library fines on the City's website, that another way they could take it up was to use setoffs, that they did some research on it and talked to Ms. Judy Johnson's office, and read Section 2.138 of the Code of Ordinances, located under Article V. Financial Affairs, Division 1. Generally, that they had seen Paul Bettencourt's Office at the Tax Accessor Collector take an aggressive approach to it with regard to personal property taxes, that in Evanston, Illinois denied non essential City services to anybody who owed money to the City, that he thought what they had to decide was if they owed money to the City and it was over the course of a pattern, then they were going to deny them non essential City services, that finally he thought that they should put the library fine and fee collections back into the Library Department and the library would have a reason to go out and collect them, that as it was presently they went to the General Fund and they never saw any benefit, that those were his solutions to solve the problem. Council Members Tatro, Goldberg and Robinson absent.

Council Member Wiseman stated that she was all for anything they could do to cut down on their waste and to collect what was owed to them. Council Members Tatro, Goldberg and Robinson absent.

Council Member Wiseman stated that she had an issue with respect to some building that was going on in the Beveraly Hills Civic Association, that she was contacted by the president of the association about some building that was going on in that subdivision, that there was a property owner who was in the process of building a one story apartment behind his home and it was in violation of deed restrictions and they did not have a building permit, according to the City's Permit Division, the association had contacted both the Legal and Planning Departments, but still the construction was going on, that she would like to see what they could do about putting a stop, at least temporarily, to see what they could do to rectify the situation, that she would like some assistance with that and would like to meet with Mr. Litke and a representative of the Legal Department to see what they could do about it. Council Members Tatro, Goldberg and Robinson absent.

Council Member Wiseman stated that with the limited purpose annexations that they had she had been contacted by a business owner in one of the areas that had been in business for many years and operated a small snow cone shop in the area and they had now been told that

they had to meet certain City codes and get certain permits and it was going to cost them \$10,000 to bring their facility up to City standards and they were looking for a temporary permit to carry them through the Spring and Summer season and they had been told that they could not do so, the Health Department would not give them that permit, and they have also shared with her that they were never notified about the limited purpose annexation and now they had been hit hard financially without any kind of assistance from the City in the way of working with them in making the transition, they could very well go under this year and she certainly did not want to see any small businesses suffer any more than they were suffering during this time, that she would like to meet with a representative of the Health Department and would like to meet with the Planning Department as well with respect to the Limited Purpose Annexations and how they affected the small mom and pop businesses. Council Members Tatro and Goldberg absent.

Council Member Galloway stated that the Fire Academy was still making indifferences among the cadets, what had happened was when a cadet was ill or gets injured on the job, it depended who they were, some of them got four weeks off, even in Phase 1, whereas others may only be able to get two weeks off, and in Phase II or Phase IV they got four weeks off, and it depended really on the individual and she still wanted a complete overhaul of the academy and make it consistent for all cadets and have the same rules apply to all, that she really wanted the Mayor to seriously look into it about the unfair treatment of some cadets versus the others, that she had some names of the ones given a longer period of time versus names of some who were only given a shorter period of time and were not able to complete their physical portion of the academy because they had been injured and did not have time to recuperate, that it was very serious matter and was still going on. Council Members Tatro, Goldberg, Wiseman and Vasquez absent.

Council Member Robinson stated that he had distributed a memo at the Council table, that it was a request for Council Member Edwards to see if she would put on the Public Safety Committee's agenda a formal request to the Legal Department to draft an ordinance that would combine several departments into a new Public Safety Department, that he hoped she would give that some consideration and they could discuss it in committee. Council Members Tatro, Goldberg, Wiseman and Vasquez absent.

Council Member Edwards stated that she wanted to congratulate community groups in the district regarding their work on US 59 and Spur 527, facility the facilitators group of West Alabama called the Black Coalition and Mr. Vanden Bosch for his work, that one of the main problems that she had seen in the whole process was that from her estimation TXDOT seemed to have worked very diligently on design but gave little thought or time to the consequence of how the traffic was going to be moved from the Spur into the communities, so it was kind of left to the City to mediate the madness that would be developed from the design and she would just like to congratulate the community and Mr. Vanden Bosch, that they still did not have the perfect design but thought they had a lot better one than they would have if Mr. Vanden Bosch had not taken the lead and charge in it and the facilitators group and the Quality of Life group. Council Members Tatro and Goldberg absent.

Council Member Edwards stated that she was at a civic club meeting last night at Hiram Clark Civic Club, under the leadership of Ms. Claudette Edwards and they were giving kudos to the Legal Department for their help on their deed restrictions, that she also wanted to congratulate the Hiram Clarke Civic Club for taking a situation on in their community and going up to Austin and winning their battle. Council Members Tatro and Goldberg absent.

Council Member Edwards stated that on Thursday night the Almeda Civic Club was looking forward to seeing the Mayor out there, that they had now a national story on the sink hole, that she had seen it on CNN and so forth, that they had worked very hard at being real partners on this effort and were really looking forward to seeing the Mayor. Council Member Tatro absent.

Council Member Edwards stated that she wanted to know if it was true, that Council Member Parker had brought up yesterday, or inferred, that there had been some type of talk of retaliation to the Council from the State folks if they did the resolution, that if it was true she would hope that whoever had the audacity to make those kinds of claims that they would just come to City Council so they would know who they were, that she resented very strongly any group of people telling them that they did not have the right to do due process in a democratic republic, that it was not a benevolent dictatorship and she did not need State officials to imply that they would retaliate against the City if they felt they needed to discuss something and indeed vote on it, regardless of how the vote came up or down, that she did not know if it was true or not, but would really like for the Mayor to find out if it was true, and did not know what difference it would make if it was true or not, but it really bothered her, that they needed more synergy with all the stuff that was going on, that not only in the State but in the Country, elected officials needed to be working together instead of trying to control and manipulate one another, that she would hope that it was not true. Council Member Tatro absent.

Council Member Vasquez asked Mr. Haines where they were in terms of writing the Drainage Utility Fund Ordinance and what the status of that was, and Mr. Haines stated that they had one more presentation tonight, one more townhall meeting, that they had been compiling a list of questions and issues that had been raised at all of the meetings and their plan was to have a presentation summarizing the results of those meetings as well as the highlights of an ordinance proposed for the TTI meeting, he believed, was scheduled for next Monday. Council Member Tatro absent.

Council Member Keller stated that they talked about a lot of somber issues in the last few weeks and thought it was becoming more so and he attended the opening of the Aquarium downtown and expected it to be unbelievable in relation to many of the others that he had attended in the area, that it was brilliant and regardless of what one's sentiment was of Mr. Fertitta he was a bright light and had done an incredible job of developing that part of downtown and it was an asset beyond measurable value, that the lines, as they could tell, were already phenomenal and thought they would continue to be and thought that it would continue to be a steady pulse to downtown and especially that part of downtown, to tie in all the way along to the eastside, that it was an incredible development. Council Members Tatro and Berry absent.

Council Member Keller stated that he wanted to compliment a couple of Public Works and Engineering employees with the Utility Customer Service, Ms. Delores Franklin and Ms. Gina Flores had handled a number of requests from the Hammersmith Community, which was large in his district, and he got a letter from their association president when they conducted a hearing and he wanted to personally thank both of them for the professionalism with which the hearing they conducted was held, that he wanted to thank them for that because when they did that it made his staff happy and made him happy, that as everyone around the table knew they did hear the bad news a lot more than the good news and he appreciated that. Council Members Tatro and Berry absent.

Council Member Quan stated that he wanted to congratulate Council Member Ellis, that he saw recently in the Texas Catholic Herald that he received the National Catholic Education Association's Distinguished Graduate Award from Saint Fracis De Sales High School. Council Members Tatro and Berry absent.

Council, Ms. Johnson, and invited them to go out to Sunnyside to see what was going on, that she was very concerned about how their health clinics were being operated, that as they knew they had eight health clinics around the City, that Monday he and his chief of staff went out there and they were delighted to see a great deal of very dedicated individuals, but also very disappointed by the way the clinic was being operated, that one of the first complaints they had was that the process of screening people was the self declaration process, they had a sliding scale, but they saw people come in Jaguars and other very expensive cars and say they have

no income so they had to treat them, that the State and County have a system that they check through Social Security numbers their income levels to verify whether they qualify for their clinics or not, but the City did not have that, that it seemed very rudimentary and something that they should address immediately, the second concern they had was the lack of billing, that there was over \$700,000 of bills that had not even gone to the federal government that they were entitled to for work that their clinics had provided and that was because they had a temporary clerk, and because of the budget restrictions they laid off that temporary clerk, for four years they had that temporary, one would think that they would have a permanent position to do billing to get the federal government to give them back the money for the services they rendered, that the third concern they raised were the prescriptions, under their protocol they give prescriptions for up to a year, so that people would receive 14 months of prescriptions and they would end up selling those prescriptions and go to another clinic and get more prescriptions, that it was an abuse that they had to stop, that they were just giving away their money for nothing, that a consolidated appointment system was instituted recently and people could not make appointments for the clinic because they could not get through on the telephone because the telephones were jammed, now had they saved money by having that consolidated system, no, they still had the same clerks sitting around waiting for people to come in and it was an inefficient change of procedure, they needed to have some accountability from the Health Department on these things, that they were all concerned about the public health and they all worked last budget cycle to make sure they restored money to the Health Department, but how do they restore money when the department was seemingly squandering opportunities that it had and was not taking care of itself as it was, that he would like an investigation of the changes and procedures to make sure that they address them, that here they were in a tight budget squeeze and people were clearly abusing the facilities who could afford otherwise to pay for prescriptions and pay for services themselves, so he ask that they look into it very seriously and immediately, and Mayor Brown stated that they would. Council Member Tatro absent.

Council Member Quan stated that as Council Member Edwards talked about they had a number of speakers in the last month come before Council requesting the Council to take some action in the opinion of the situation in Iraq, that he had introduced a resolution supporting the United Nations inspectors in Iraq, that he knew the Mayor had declined to put it on the agenda, but thought that democracy at least deserved a debate on the issue, they may lose, and there may be many of them on the Council who did not support that, but he thought it was an issue that affected their daily lives in the Country and City and their abilities to operate, that they had seen the affects of 9/11, a war would have even greater affects on their economy, not to mention the lives of American citizens as well as citizens in other countries, so he would again ask that they not be intimidated by rumors that Austin or somebody else may have some retribution towards them, but as responsible elected officials to at least put it on their agenda and have a debate on it. Council Members Tatro and Parker absent.

Council Member Goldberg stated that right now there was construction going on for Galleria IV on West Alabama between the two Galleria's, that there was lane closure permits granted for two out of the four lanes, but the construction companies there were really abusing it and were actually using up three lanes and it was very difficult for traffic to get through in an area that was very congested anyway and wondered if someone from either Planning or Public Works could either pull one of those lane closure permits or as the companies to abide by the permits that they were granted, and Mayor Brown stated that they would have the appropriate department follow up and take care of that. Council Members Tatro, Wiseman and Parker absent.

There being no further business before Council, the City Council adjourned at 10:23 a.m. upon MOTION by Council Member Keller, seconded by Council Member Vasquez. Council Members Tatro, Wiseman and Parker absent.
