

This multi-vendor award for IT Professional and Consulting Services will allow the City to implement infrastructure solutions to improve resiliency, manage risks, improve response times for IT support to the end users, and continually audit and maintain operational systems and services.  These services will support on-call services and projects in support of the City's stabilization and strategic efforts. The City will also be able to access extended support for desktop, endpoint application, patch management, and end user device management.
