OPTIMIZING EMERGENCY RESPONSE CARE THROUGH REMOTE EMERGENCY TELEMEDICINE



Emergency Medical Service and Hospital Based Emergency Care are worth over \$50 Billion Annually and are Deeply Inefficient



Emergency Medical Services transport approximately 21 million patients per year to overcrowded hospital emergency departments (ED) at an average cost of \$3,500 per visit, including over \$2,100 in transportation alone



Approximately 40% of patients transported by ambulance are non-emergency and could be treated outside of a hospital Emergency Department and only 39% result in admission to the hospital



As much as \$10 billion could be saved in hospital emergency department costs for patients who could be diverted to other lower-cost providers of care such as clinics and other ambulatory care centers

ETHAN: A History

2008 Houston Fire Department (HFD) began a nurse help-line at the Emergency Dispatch Center

Within 3 months, 20% of the calls were able to be redirected to the nurses' call line versus EMS dispatch. However, there were liability concerns related to a no-dispatch approach and 80% of the calls were still being sent back to EMS by the nurses

2014 HFD launched Emergency Telehealth and Navigation = ETHAN + SYNAPSE

EMS responders in the field, through ETHAN, can connect with a physician via video link and, upon consultation with the patient, present alternate care and transportation options

ETHAN is currently deployed in over 200 emergency vehicles in the City of Houston and is supported by 15 physicians

2020 ETHAN was moved to the highly secure TEAMS platform

ETHAN's current funding source runs out as of February 2025

>90% success in Ambulance avoidance for low Acuity Patients

\$22 million in Ambulance savings alone since 2014

Average of 44 minutes saved per EMS encounter

Enabled Payor Directed Emergency Response Care away from EDs

ETHAN has become an increasingly critical resource for the Houston Fire Department, especially as the department struggles with a current shortfall of 600 firefighters

Since 2014, ETHAN Created Significant Efficiency and Cost Savings for the COH, Freeing Resources to Serve the City's Most Acute Patients

ETHAN Step-by-Step

- 1 911 Call is Placed and EMS Dispatched
- 2 EMT Field Acuity Assessment
- 3 Video Call to ETHAN Physician By Emergency Responder
- 4 Disposition by ETHAN Physician using SYNAPSE Navigation
- 5 Directed Care of Patient

How ETHAN + SYNAPSE Works

ETHAN Provides a Proven and Cost-Effective Telehealth Alternative to Traditional Ambulance Navigation for Other Municipalities Both Regionally and Nationwide



ETHAN's platform could be used for 30%-35% of 911 Ambulances dispatched throughout the USA, equaling 6.3 million potential ETHAN visits per year



This would result in municipalities saving 30% - 40% on ambulance navigation costs, depending on volume and geographic size



EMT visit time for low acuity patients could be reduced with ETHAN by as much as 60%, significantly increasing the capacity of overburdened municipalities

ETHAN Transition to an LGC

- ETHAN has provided a critical service to the City of Houston and its residents since 2014, yet it has struggled to maintain sustainable funding streams
- In order for the ETHAN/Synapse platform to continue to evolve, it needs to do so outside of the natural constraints of COH operations
- Outside of the City, as an LGC, ETHAN will be able market its services to other municipalities, providing the same positive benefits it has demonstrated in Houston
- ETHAN Health, LGC will also be able to partner with Insurance Providers to ensure that ETHAN patients are not only receiving appropriate care, but doing so in ways that are financially beneficial to them and their providers
- Clinics, who meet ETHAN's program criteria, will, as sponsors, have their clinic(s) featured on the ETHAN doctor portal, if approved by ETHAN Health, LGC's counsel
- Through these revenue streams ETHAN Health, LGC will be able to not only derive its own sustainable funding but will ultimately provide sources of funding that will revert back to the COH to support critical areas of emergency care throughout the City

License Fees for Use of the ETHAN Platform

Municipal Governments as Clients will pay:

- 1. Base license fee for use of the platform and ETHAN Doctors
 - 2. Per incident fee for all patients encounters that result in redirection away from the ED



Directed Navigation Fees for Healthcare Partners through ETHAN

Insurance Partners who are either Payors or Sponsor (i.e.. Clinics or Urgent Care Providers) pay fees for:

- A pool of Partner Payor covered lives for whom ETHAN provides directed navigation services
- 2. Ongoing sponsorship referral fees for institutions wishing to be prioritized on the ETHAN platform for ETHAN doctors



Ad Fees for Clinics Featured on ETHAN

- Clinics who meet ETHAN program criteria will pay a fee:
- 1. For being featured on the ETHAN doctor's portal
 - This revenue stream will only be implemented upon approval by ETHAN Health, LGC's Counsel

ETHAN Health, LGC Revenue Streams

ETHAN Health, LGC Board Composition

- The ETHAN Health, LGC Board of Directors will be composed of 7 individuals, 2 of whom will be ex-officio, with diverse backgrounds, expertise, and a shared commitment to serving the community's interests.
- The leadership structure of the Board of Directors of ETHAN Health, LGC consists of several key positions that guide decision-making, oversee operations, and represent the corporation to the community.
- The key roles in ETHAN Health, LGC's board leadership are as follows:
 - ✓ Chairperson
 - ✓ Vice Chairperson
 - ✓ Treasurer
 - ✓ Secretary
 - ✓ Committee Chairs

LGC Formation Document:

 This document enables the formation of the LGC and outlines its purpose, operational structure, bilaws and board composition and function.

Interlocal Agreement with the City of Houston:

- This document outlines the relationship between the City of Houston and ETHAN Health, LGC as relates to the provision of ETHAN Services and the functioning of the

LGC

Licensing Agreement with the City of Houston:

 This document outlines the specific Intellectual Property being licensed by the City of Houston to ETHAN Health, LGC and the terms of that agreement

-These terms include the fees to and revenue share with the City of Houston

- The City of Houston will receive a \$450,000 License Fee per annum as soon as ETHAN Health, LGC has either enough cash reserves for 12 months of operations or when ETHAN Health, LGC enters the 5th year of its operations (whichever is sooner)
- After the milestone in the first bullet is reached, ETHAN Health, LGC will pay 100% of its net revenues to the City of Houston
- ETHAN Health, LGC and the City of Houston will begin to share net revenues once the milestone in the second bullet is met
