# PASSPORT SERVICES APPLICATION CHECKLIST



### **Passport Services**

The Municipal Courts Department on behalf of the U.S. Department of State accepts passport applications for U.S. citizens wanting to get a new passport. Citizens may submit an Application (DS-11), for U.S. Passport in person. We can ONLY accept the DS-11 passport application. We cannot accept the DS-82 renewal application. The DS-82 renewal application must be completed and mailed by the applicant to the address on the form. Instructions on completing and mailing a passport renewal application can be found on the U.S. Department of State website www.travel.state.gov.

# You must apply in person using form DS-11 if at least one of the following is true:

- ☐ You are applying for your first U.S. passport, or
- ☐ You are under the age of 16, or
- ☐ Your previous U.S. passport was issued when you were under age 16, or
- ☐ Your previous U.S. Passport was lost, stolen, or damaged, or
- ☐ Your previous U.S. Passport was issued more than 15 years ago, or
- ☐ Your name changed since your U.S. passport was issued and you are unable to legally document your name change.

# **PASSPORT APPLICATION CHECKLIST**

READ CAREFULLY: EACH PERSON APPLYING FOR A U.S. PASSPORT WILL NEED THE FOLLOWING ITEMS:

### ☐ CORRECTLY COMPLETED DS-11 APPLICATION

- O Download application online at www.travel.state.gov
- One application per applicant
- O Complete in **black ink** only
- O Do not sign application until requested to do so by a passport acceptance agent
- O Passport renewal application DS-82 is not accepted

### ☐ PROOF OF U.S. CITIZENSHIP

Bring one original (plus one photocopy\*) of the following:

- O Previously issued U.S. Passport undamaged (may be expired), or
- O U.S. Birth Certificate or certified copy issued by the city, county, or state, or
- O Certificate of Naturalization, or
- O Consular Report of Birth Abroad or Certification of Birth, or
- O Certificate of Citizenship
- O For minors: Under 18, the original birth certificate must be presented.

Note: Original proof of citizenship must be submitted with your application. However, your original document will be mailed back to you in a separate envelope.

### ☐ PASSPORT PHOTO

- O (1) one color photo
- O 2" x 2" inches in size
- O Taken within the past 6 months, showing current appearance
- O Full Face, with neutral facial expression
- O Front view with a plain white or off-white background
- O Between 1" inch and 1 3/8" inches from the bottom of the chin to the top of the head
- O Taken in normal street attire
- O No glasses

### □ PROOF OF IDENTITY

Bring one original (plus one photocopy\* front and back) of the following:

- O Valid State Driver's License, or
- O Valid State Identification Card, or
- Naturalization Certificate, or
- O Prior Undamaged U.S. Passport (may be expired), or
- O Government Employee ID, or
- O Official Military ID Card

**Minors:** For applicants under 16 years of age both parents must be present or provide official consent. If both parents cannot be present go to www.travel.state.gov for more information.

\*Photocopies must be: legible, on white 8.5" x 11" standard paper, black and white, and single sided.

#### ☐ MAKE AN APPOINTMENT
