Benny Agosto, Jr. is a partner at the Houston personal injury law firm of Abraham, Watkins, Nichols, Agosto, Aziz & Stogner. He has been practicing law since 1995 and is board certified in Personal Injury Trial Law by the Texas Board of Legal Specialization. Over the course of Mr. Agosto's legal career, he has represented hundreds of individuals who have been seriously injured or families who have lost loved ones due to negligence. His areas of practice include, but are not limited to, work place accidents, motor vehicle, 18-wheeler accidents, wrongful death, environmental law, explosions, electrocutions, and maritime accidents.

In addition to practicing law, Mr. Agosto is active in the community. He is a past President of both the Hispanic National Bar Association and the Mexican American Bar Association of Texas. He is the Founder and President of the Mexican American Bar Association of Texas Foundation and is the Co-Founder of the HNBA Legal Education Fund. He is also the President of the Houston Bar Association and serves as ex Officer to the Houston Volunteer Lawyers Board, Houston Lawyer Referral Service Board and Dispute Resolution Center Board.

His involvement in the legal profession and community has earned him honors locally and nationally. He has received the President's Award from both the State Bar of Texas and Houston Bar Association, the Civil Rights Medal from the Anti-Defamation League, the Peter Torres, Jr. Community Service Award from the Hispanic Issues Section of the State Bar of Texas, The Humanitarian Award from the Hispanic Learning Center, and the Peter Perlman Service Award from the Litigation Counsel of America.
