**REQUEST FOR RELEASE OF FUNDS**

On or about Monday, February 9, 2015 City of Houston's Housing and Community Development Department will submit a request to the U.S. Department of Housing and Urban Development for the release of the following funds:

**Community Development Block Grant (CDBG) funds authorized by Title I of the Housing and Community Development Act of 1974 (P.L. 93-383, as amended), to undertake a project known as, to undertake a project known as:**

**Project Title: Dowling Street Infrastructure Reconstruction**

**Location: Dowling Street between Elgin and McGowen, Houston, Texas 77004**

**Purpose of project: Reconstruction of Dowling Street from Elgin Street to Dennis Street (approximately 1415 feet in length). Work includes the construction of reinforced concrete curb and gutter pavement, sidewalks, wheelchair ramps, driveways, storm sewer, sanitary sewer, water lines, landscaping, including bioswales, rain gardens, sodding, tree planting, and protection. Scope will also include the installation of storm water pollution prevention lines from Dennis to McGowen.**

**In order to ensure proper site mitigation, petroleum resistant piping and gaskets or other petroleum contaminated design considerations will be added as needed at the three potentially petroleum contaminated areas (PPCA) locations: PPCA 1 extends along Dowling Street at the intersection of Elgin Street from Station 65+20 to Station 67+20. PPCA 2 extends along Dowling Street at the intersection of Tuam Street from Station 74+00 to Station 76+00. PPCA 3 is located at the north end of the project area from Station 82+70 to the end of the project at Station 83+60 on Dowling Street at the intersection of McGowen Street.**

**FINDING OF NO SIGNIFICANT IMPACT**

The City of Houston has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. **PUBLIC COMMENTS**

Any individual, group, or agency disagreeing with this determination or wishing to comment on the project may submit written comments to the City of Houston, Housing and Community Development Department, ATTN: Environmental Review Officer, 601 Sawyer, 4<sup>th</sup> Floor, Houston, Texas 77007. All comments received by the close of business on Friday, February 6, 2015 will be considered by the City of Houston prior to authorizing submission of a request for release of funds. Commentors should specify which part of this Notice they are addressing.

**RELEASE OF FUNDS**

The City of Houston certifies to HUD that Annise Parker, in her capacity as Mayor, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities, and allows the City of Houston to use Program funds.

**OBJECTIONS TO RELEASE OF FUNDS**

HUD will consider objections to its release of funds and the City of Houston certification received by the close of business on Tuesday, February 24, 2015 or a period of fifteen days from its receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer or other officer of the City of Houston approved by HUD; (b) the City of Houston, as Responsible Entity, has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the project have committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58) and shall be addressed to: U.S. Department of Housing and Urban Development, 1301 Fannin Street, Suite 2200, Houston, Texas 77002. Potential objectors should contact HUD to verify the actual last day of the objection period.
