## Recovery (DR) Program for Hurricane Ike Round 2, Phase 2. The City, through its Housing and Community Development Department (HCDD), holds two housing contracts with GLO, currently \$62,410,965.82 for its Single Family activities and \$92,656,181,96 for its Multifamily activities (including \$32,555,163 to the City for the Subsidized Housing Allocation, which the City will use in collaboration with the Houston Housing Authority (HHA)). The total amount of the City's Housing portion of Round 2 Hurricane Ike funds is \$155,067,147.78. The Single Family contract has been amended five times and the Multifamily contract has been amended four times. GLO has requested budget changes to the Single Family contract, which will assist when the project is closed out by March 31, 2018. In addition to the changes listed by GLO, HCDD would like to move the \$1,254,264,96 in HCDD Project Delivery from the Multifamily contract (13-181-000-7294) to the Single Family contract (13-182-000-7295). These funds were moved originally from the Single Family contract to the Multifamily contract in Amendment #1 for both contracts. The total amount awarded to the City remains at \$155,067,147.78.
