

## Public Notice

1) The City of Houston (City), through its Housing and Community Development Department (HCDD) is proposing to administer the New Home Development Program (NHDP), resulting from a waiver for new construction activities under the Community Development Block Grant (CDBG) Program due to the impact of Hurricane Harvey. HCDD created Guidelines for the proposed Program. The NHDP Guidelines will be published and available for review and comment on HCDD's website [www.houstontx.gov/housing](http://www.houstontx.gov/housing) and at HCDD's offices.

2) HCDD is proposing to use the Contractors already procured for rehabilitation, reconstruction and new construction of single-family housing for the NHDP. The Contractor information was posted in a Public Notice on January 5, 2018, amended on February 7, 2018, as follows:

3) HCDD may allocate up to \$12,517,529.00 of Tax Increment Reinvestment Zone (TIRZ) funds and \$6,665,326.00 in CDBG funds to the NHDP for said construction activities.

Upon completion of the fifteen-day public comment period, HCDD will request City Council action.
