Public Notice

The City of Houston (City) through its Housing and Community Development Department (HCDD) is requesting approval of an ordinance authorizing an amendment template form for the Community Development Block Grants Disaster Recovery 2017 (CDBG-DR 17) program to be executed on existing agreements between the City, the borrower and the Owner on multiple Multifamily CDBG-DR 17 projects (Table below).

The CDBG-DR 17 Program Template Loan Agreement contains a discrepancy within a provision regarding the date on which interest on the loan shall begin to accrue. The discrepancy exists between varying sections within the Loan Agreement itself as well as with the Note and Deed of Trust on each project. These loans require interest accrual following the Approved Construction Period according to the loan note and/or following Project Completion according to the loan agreement.

The approval of the Amendment form will allow HCDD to amend the Loan Agreements to ensure the Loan Documents for each project are accurate and consistent.
