MWSBE Awards Report FY2024 : Jul 01, 2023 - Mar 31, 2024

Background

The Office of Business Opportunity is committed to cultivating an inclusive and competitive economic environment in the City of Houston by promoting the success of small businesses and developing Houston's workforce, with a special emphasis on historically underutilized businesses and disenfranchised individuals.

In compliance with Chapter 15, Article V of the City Code of Ordinances, this report details the progress city departments have made towards attaining the utilization goals established for the City's MWSBE program. In addition, for the purpose of reporting the awards to certified firms on all city-related contracts, this report includes the dollars amounts awarded to all certified firms including Disadvantaged Business Enterprises (DBE), Airport Concession Disadvantaged Business Enterprises (ACDBE), Historically Underutilized Businesses (HUB) and Lesbian, Gay, Bisexual and Transgender Business Enterprises (LGBTBE). This data can be found in the appendices.

MWSBE Awards Summary

For fiscal year 2024, from Jul 01, 2023 - Mar 31, 2024, the City of Houston awarded a total of \$1,965,580,424 to firms on construction, professional services, and goods & services agreements, with \$449,119,969 awarded to certified minority, women, and small, business enterprises (MWSBE) firms. Of that, \$140,005,345 were exempt contracts, \$507,517,865 were contracts with waivers, and \$4,799,867 were non-goal-oriented contracts. Therefore, the total dollar amount awarded on goal-oriented contracts was \$1,313,257,347, of which \$376,315,514 was awarded to certified MWSBE firms, yielding an average utilization rate of 28.7%.

When analyzing participation of MWSBE firms on **goal-oriented** contracts by **ethnicity**, Hispanic-owned businesses received the largest share-\$134,962,108 or 35.9% of the total amount awarded to certified firms. Black-owned businesses came in second, \$87,976,368 award or 23.4% of dollars awarded. Otherowned firms came in third with \$71,699,266 or 19.1%. Asian- owned firms were fourth with \$44,652,394 or 11.9%. Caucasian Women-owned firms were fifth with \$34,672,228 or 9.2%. Non-minority Maleowned firms were six with \$2,093,062 or 0.6%. Awards to certified firms each on these contracts totaled 1381 with the following breakdown: Hispanic:386, Black:355, Asian:232, Caucasian Women:206, Non-minority Male:117, Other:54.

When analyzed by **industry**, MWSBE certified firms on **goal-oriented** construction contracts were awarded \$170,435,786, which is 29.6% of the total amount of \$576,654,887 awarded in all city-related construction projects. A total of \$106,227,053 was awarded to certified firms on professional services contracts out of 37.7% of all professional services contracts awarded citywide, A total of \$99,652,675 was awarded to certified firms on goods & services projects, which is 21.9% of \$455,036,609 awarded to all goods & services projects citywide.

Summary of Exempt and Contracts with Waivers

As stated above, \$140,005,345 were exempt contracts. The remaining \$507,517,865 include contracts that are subject for approval by OBO for a goal waiver due to sole source, non-divisibility, cooperative purchasing agreements, DIR, HGAC, no certified firms available, etc. Please see Appendix A for more details.

Certification Types

Minority Business Enterprise (MBE) certification applies to firms owned and operated by minorities. MBE goals may be applied to any locally funded contract type.

Women Business Enterprise (WBE) certification applies to firms owned and operated by females. As of July 1, 2013, pursuant to amendments to Chapter 15, Article V of the City Code of Ordinances, WBEs have been reinstated on construction contracts, therefore, WBE goals are now applied to any locally funded contract types.

Small Business Enterprise (SBE) certification is race and gender neutral, and applies only to eligible firms in the construction industry. SBEs can be used, up to 4%, to meet contract specific subcontracting MWBE goals on construction related contracts.

Persons with Disabilities Business Enterprise (PDBE) certification applies to eligible firms owned and operated by a disabled veteran or individuals with an existing medically determined physical or mental impairment of a chronic or permanent character. PDBE utilization may be used to augment citywide goals set by City Council. Most PDBEs have multiple certification types. At the time that a contract is awarded, the prime contractor determines which certification type will be utilized. In most cases, PDBEs are utilized as an MBE or SBE.

Disadvantaged Business Enterprise (DBE) certification is a federal certification and applies to firms owned and operated by economically disadvantaged individuals. DBE goals apply only to U.S. Department of Transportation contracts that receive Federal financial assistance.

Airport Concessionaire Disadvantaged Business Enterprise (ACDBE) certification applies to airport concessions only. Contracts awarded to these certified firms are reported separately in the appendices.

Historically Underutilized Businesses (HUB) certification based on ethnicity, U.S. Citizenship, Texas residency and principal place of business in the State of Texas. See attached Appendix.

Lesbian, Gay, Bisexual, Transgender, Business Enterprises (LGBTBE) certified by the National LGBT Chamber of Commerce to promote economic growth and contracting opportunities. See Appendix.

Goal Oriented Contracts

The following are the types of goal-oriented contracts and their annual citywide goals set by City Council. These projects are goal-oriented, which requires MWSBE utilization.

- Construction contracts are related to construction projects above \$1M. The citywide goal for construction contracts is 34%.
- Professional Services contracts (also known as Regulated contracts) require a professional license e.g. architect, engineer, attorney, or accountant etc. The citywide goal for professional services contracts is 24%.
- Goods & Services* contracts provide for the supply of goods and non-personal or nonprofessional services above \$100K. The citywide goal for goods & services contracts is 11%.

The following are subcategories under goods & services contracts. These are non-goal-oriented contract types and do not have citywide goals set by City Council. Note: the utilization of certified vendors on purchase orders and Pcards augments the citywide goal achievement percentage. Purchase orders and Pcard purchases are included in the "goods & services total" in this report.

- Purchase orders: direct orders for various purchases made from vendors.
- PCard purchases: direct purchases from vendors using City of Houston purchasing cards

Contracts with Waivers** are contracts that don't have a goal per Chapter 15, Article V, Section 15-83, these contracts must be reviewed and approved by the Office of Business Opportunity (OBO). The following reflect the most frequent circumstances under which OBO may approve a request to waive a contract goal:

- **Emergency Contracts** A public or administrative emergency exists which requires the goods or services being procured to be provided with unusual immediacy.
- **Specialized Contract** If goods and services being procured are specialized, technical or of a unique nature as to require the contracting department to select its contractor without application of a goal.
- Economic Burden or Risk If requiring a goal would impose an unwarranted economic burden or risk on the City or unduly delay acquisition of the goods or services, or is not in the best interest of the City.
- **No MWSBEs Available** _ There are no MWSBEs available in the market to perform the work required in the contract or who possess the specialized license or certification required to do the work.
- Non Divisible The contract cannot be divided to include the use of subcontractors.
- **Sole Source** Contracts awarded to meet a need that can only be supplied from a firm that provides specialized and/or unique products or services.
- Direct shipment Contracts where the goods are directly shipped to the customer.
- Minimal MWSBEs Available The level of MWSBE availability would produce minimal MWSBE participation.
- * As per the recommendation of Strategic Purchasing Division, 'Purchasing' Contracts will be referred to as 'Goods & Services'. The Report has been edited to reflect this change.
- **Departments are required to request a 0% goal from OBO, however, in some cases a department has requested a 0% goal directly from City Council.

Non-Goal-Oriented Contracts – Construction contracts \$1,000,000 or less and Goods & Services contracts \$100,000 or less. These are contracts that do not require certified firms or a review from the Office of Business Opportunity.





Administration and Regulatory Affairs

Details by Department 7/1/2023-3/31/2024

The Administration and Regulatory Affairs Department (ARA) provides efficient and logical solutions to administrative and regulatory challenges. The department oversees Parking, Operations/3-1-1, Payroll, Administrative Services, BARC (the City's Animal Shelter and Adoption Facility), Transportation and Insurance Management.

Year to date in As of Mar 31, 2024, Fiscal Year 2024, ARA awarded \$30,268,717, of which \$695,623 was awarded to certified firms, accounting for 2.3% utilization over all awards. However, from this amount, \$28,408,751 was either exempt from MWBE goals, granted a waiver, or non goal-oriented. From the remaining \$1,859,967, the department registered 32.5% utilization by awarding a total of \$604,183 to certified firms.



The Finance Department's (FIN) mission is to safeguard the fiscal integrity of the City, and enable City stakeholders to do the same. We will do this by sustaining and growing a dynamic organization filled with strong people that use rigorous policies, processes, and systems. Strategic Purchasing (SPD) and General Government (GG) transactions are included in the summary below.

Year to date in As of Mar 31, 2024, Fiscal Year 2024, FIN awarded \$18,738,405, of which \$8,481,645 was awarded to certified firms, accounting for 45.3% utilization over all awards. However, from this amount, \$17,405,822 was either exempt from MWBE goals, granted a waiver, or non goal-oriented. From the remaining \$1,332,583, the department registered 65.1% utilization by awarding a total of \$867,107 to certified firms.















Details by Department 7/1/2023-3/31/2024

The Houston Health Department (HHD) provides traditional public health services and seeks to use innovative methods to meet the community's present and future needs. The department conducts numerous projects, one of which is the AIM project, whereby HHD employees go door-to-door in selected neighborhoods performing assessments, linking residents to services and providing immediate follow-up. The department also partners with nonprofit health centers and hospital district primary care clinics to enhance access to services for residents and improve the City's health profile.

Year to date in As of Mar 31, 2024, Fiscal Year 2024, HHD awarded \$32,586,532, of which \$2,093,414 was awarded to certified firms, accounting for 6.4% utilization over all awards. However, from this amount, \$27,612,218 was either exempt from MWBE goals, granted a waiver, or non goal-oriented. 











FY2024 Awarded Contracts with DBE Certified Firms

The United States Department of Transportation requires recipients who receive more than \$250,000 in federal funds to establish a Disadvantaged Business Enterprise Plan and set participation goals on all federally-assisted projects as well as setting a triennial goal. On October 23, 2013, the Houston City Council approved a DBE Triennial Goal for the Houston Airport System of 29% for the participation of Disadvantaged Business Enterprises and 3.7% goal for the race/gender neutral component on all Houston Airport System contracts; funded (wholly or in part) by the U.S. Department of Transportation.

As of Mar 31, 2024, Fiscal Year 2024, DBE Certified Firms were utilized on a total of 7 contracts. The total amount awarded to these contracts was \$108,415,049. From that amount, DBE Certified firms were awarded \$30,155,319 for a combined participation of 27.8%.

Hobby Airport (HOU) are primary airports. The City has received federal funds authorized for airport development after January 1988 authorized under Title 49 of the United States Code. The City has signed airport grant assurances that it will comply with 49 CFR, Part 23.





On March 4, 2021 Mayor Sylvester Turner signed an executive order calling for the inclusion of NGLCC LGBT Business Enterprise (Certified LGBTBE) suppliers among the City's pool of certified companies to ensure they have equitable access to contracting and procurement opportunities throughout the city. For LGBT citizens of Houston, this inclusive initiative provides fair and equal access to contracting opportunities and economic development programs that drive innovation, create jobs, and promote economic growth throughout the region.


This executive order makes Houston the first city in Texas, and one of the largest in the nation, to create an initiative to intentionally expand its inclusion of LGBT-owned businesses in municipal contracting and procurement opportunities. Economic Impact

651 Businesses

From July 1, 2023 through March 31, 2024, the City provided the support to hire 651 MBEs, WBEs, SBEs, PDBEs, DBEs, ACDBEs HUB, and LGBTBE certified businesses.

Out of 651 certified businesses, fourteen thousand jobs were supported.
