Property: 1543 Columbia Street, Lot 2, Block 137, Houston Heights Neighborhood Subdivision. The property includes a historic 864 square foot, one-story wood frame single-family residence and a detached garage situated on a 6,6000 square foot (50' x 132') interior lot.

Significance: Contributing Bungalow style residence, constructed circa 1920, located in the Houston Heights East Historic District.

Proposal: Alteration: Addition

- Raise existing historic structure 4" (from 26" to 30")
- Extend rear ridge line of historic structure back to rear addition at a lower height to differentiate
- 2-story rear addition
- Max. ridge height at 29' 4" with a 6:12 roof pitch (matches contributing structure's roof pitch)
- Attached garage with alley access
- On South elevation of historic structure, move existing window and infill.
- On North elevation of historic structure, move existing window and infill. Create new window opening with pair of windows.
- Single-hung, inset & recessed, 1/1, wood windows
- Smooth, cementitious siding

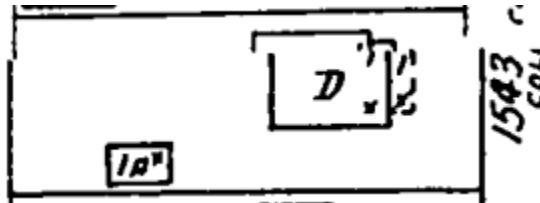

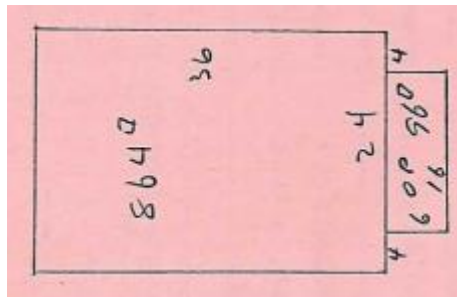

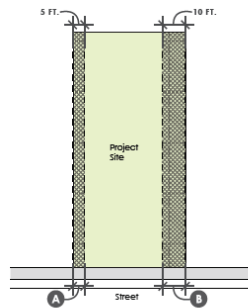

B	5 FT.	Minimum distance between the side wall and the property line
B	REMAINING	Difference between minimum side setback of 5 feet and minimum cumulative side setback
C	6 FT.	Minimum cumulative side setback for lots less than 35 feet wide
C	10 FT.	Minimum cumulative side setback for a one-story house
C	15 FT.	Minimum cumulative side setback for a two-story house

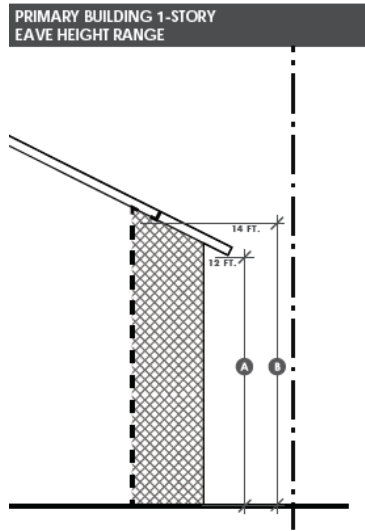

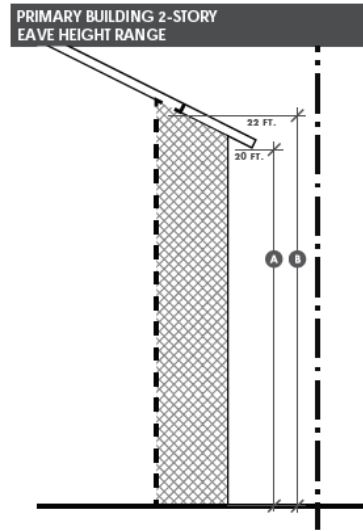

HEIGHTS DESIGN GUIDELINES MEASURABLE STANDARDS

Rear Setbacks (Addition and New Construction)

The City of Houston requires a minimum setback of three feet from the rear property line for all properties, except under the following circumstances:

- A front-facing garage which is located with its rear wall at the alley may have a zero-foot setback.
- An alley-loading garage generally must be located to establish a minimum of 20 feet of clearance from an opposing alley-loading garage door, the rear wall of a front-facing garage, or a fence; a 24-foot clearance is preferred.



10 FT.	Maximum first floor plate height
9 FT.	Maximum second floor plate height


Detached Garage Ridge Height (New Construction)

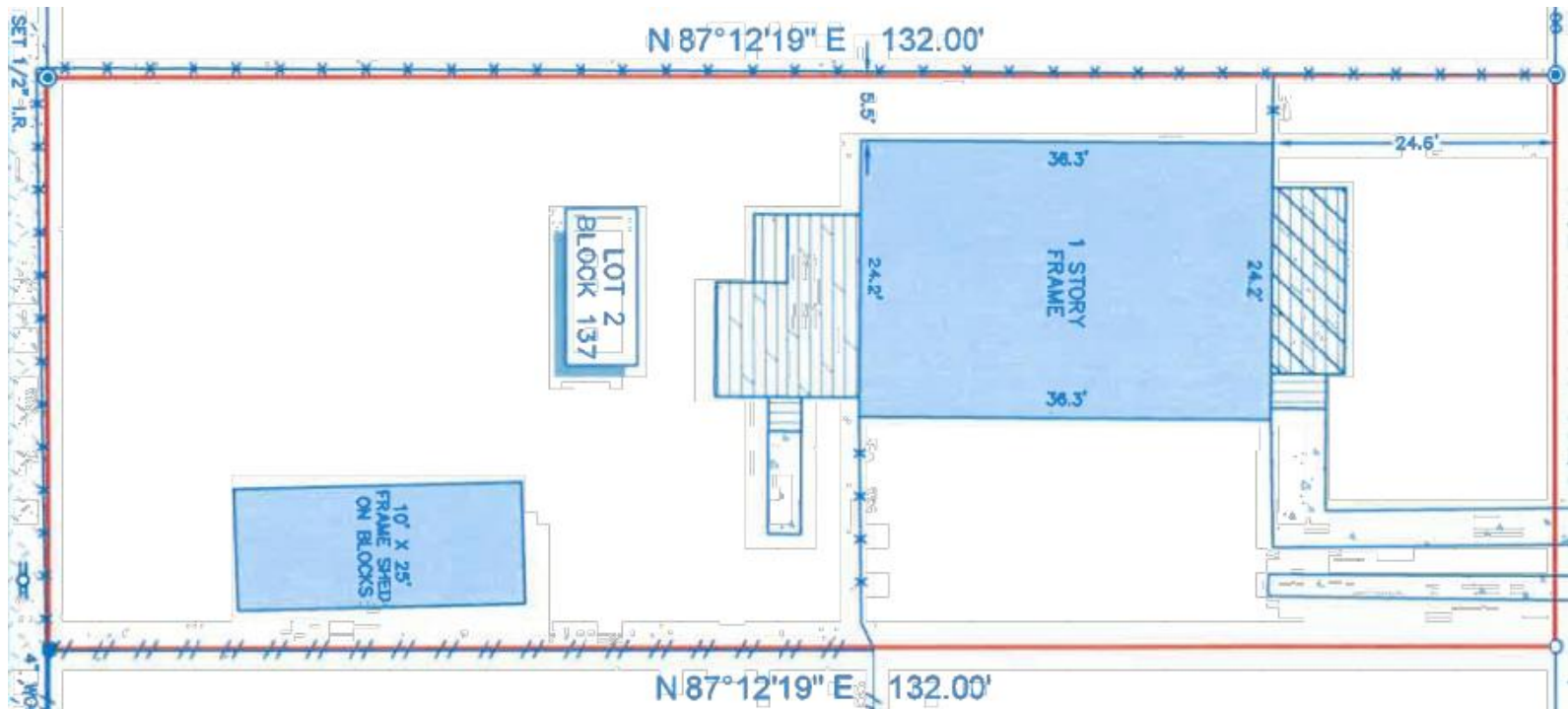

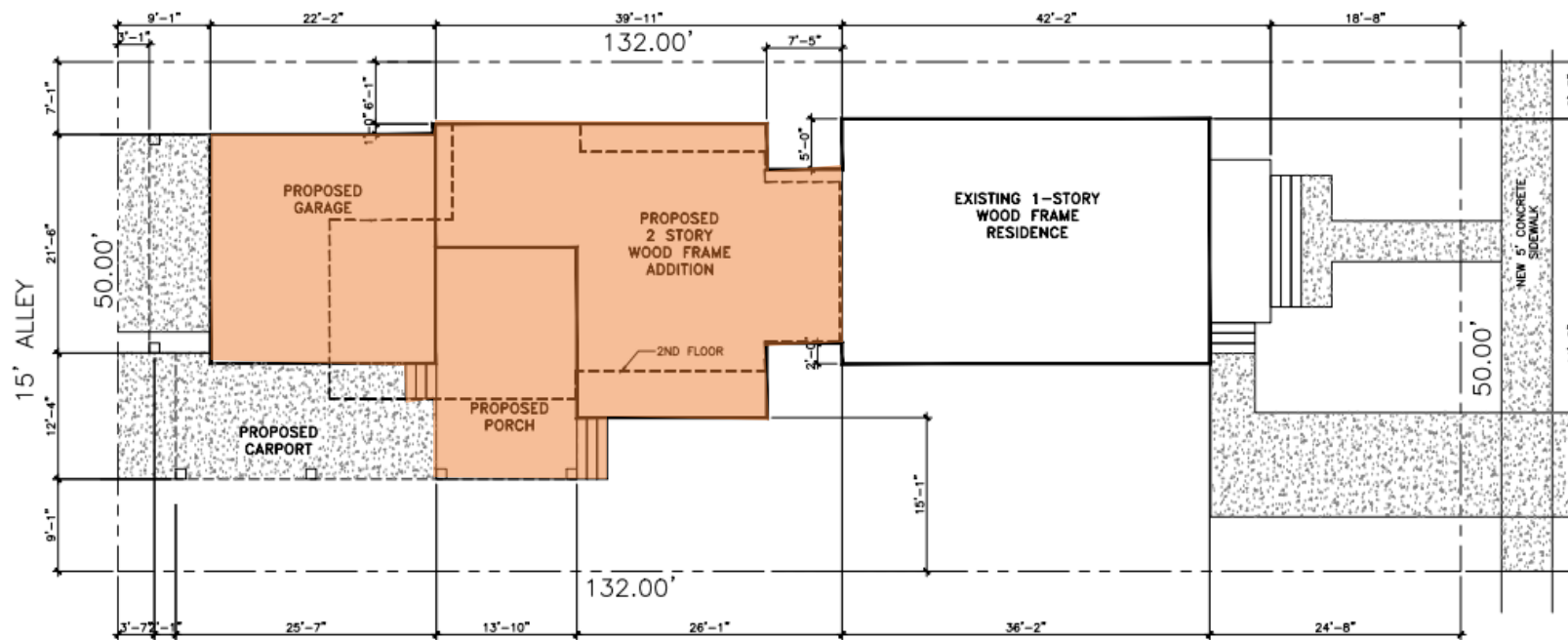

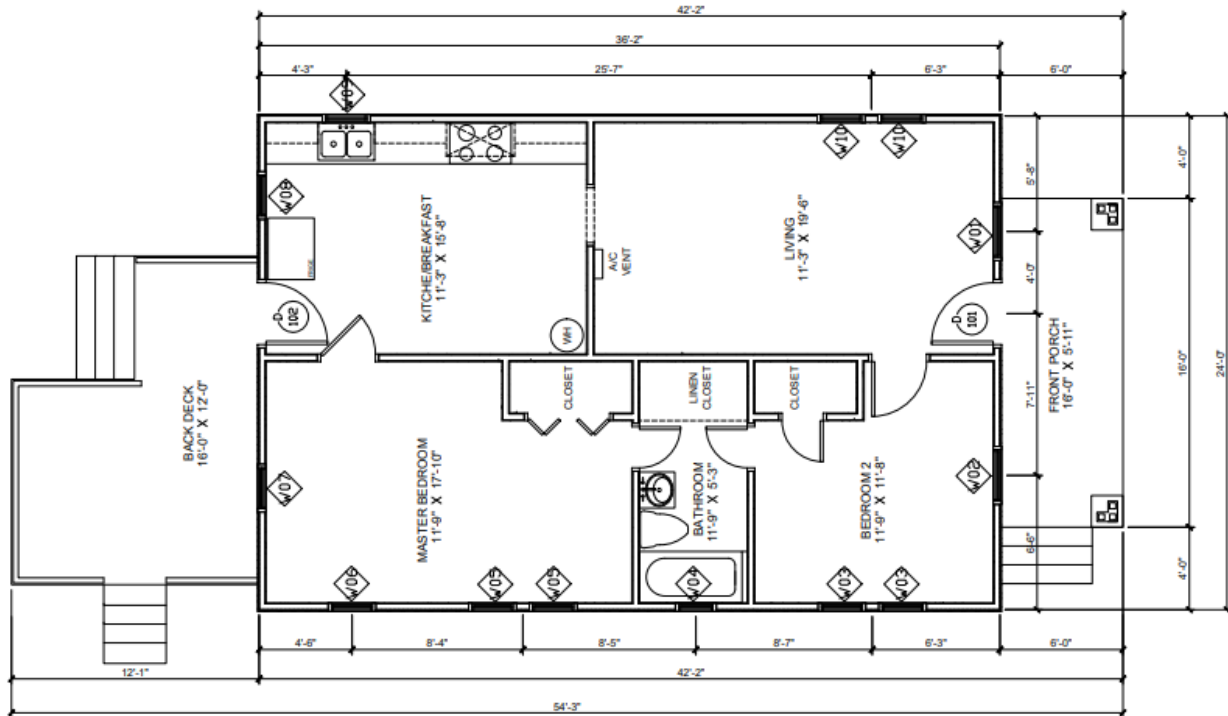
Existing Site Plan



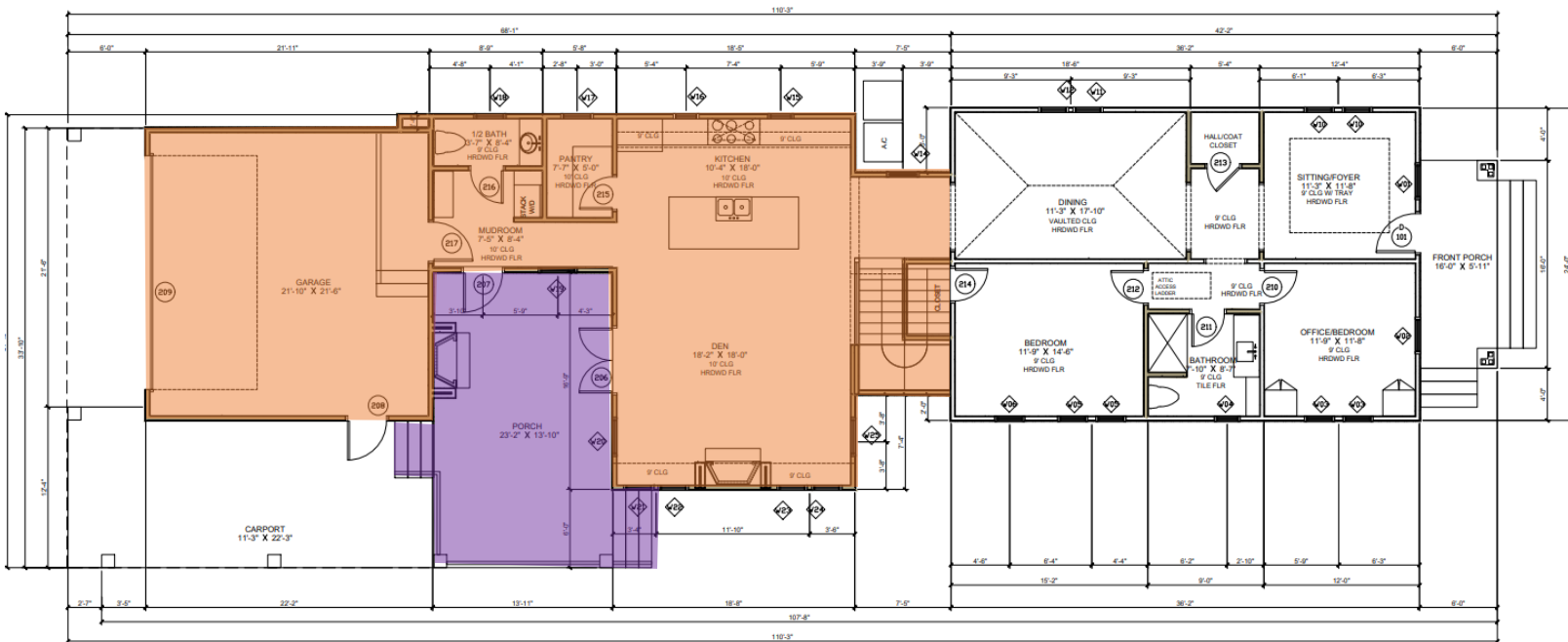
Proposed Site Plan



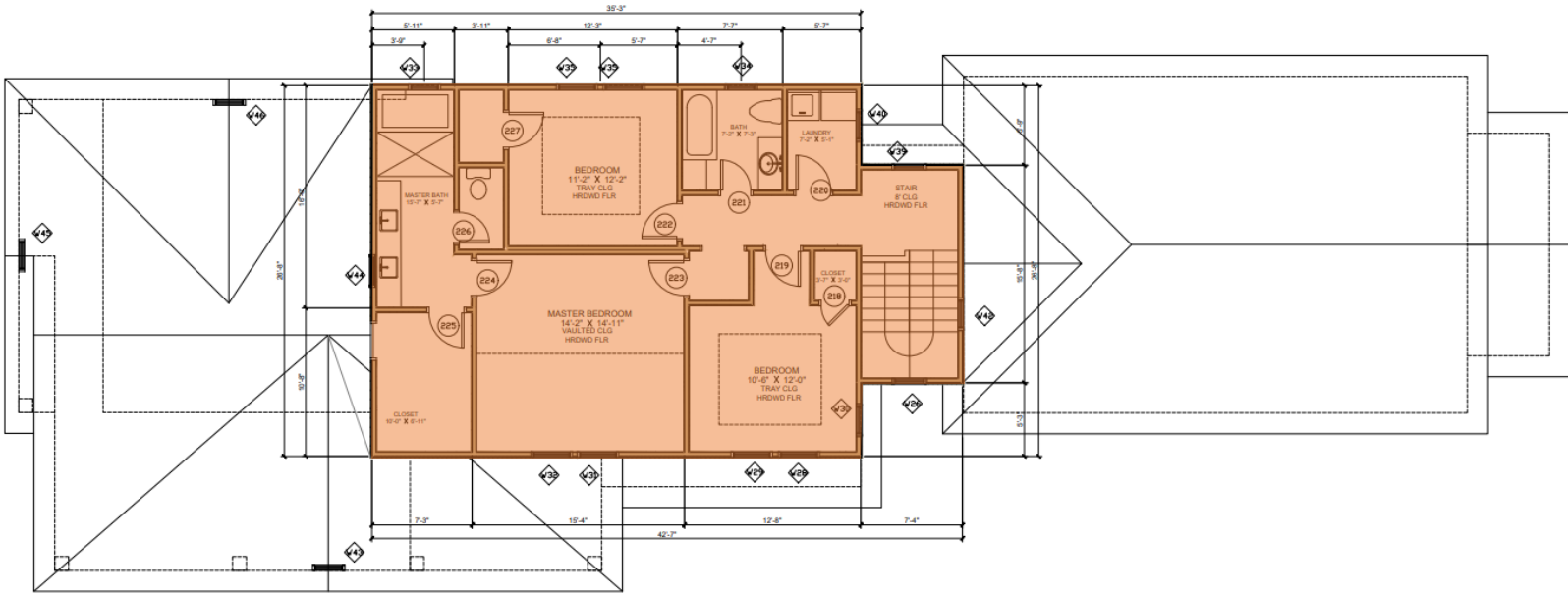
Existing Floor Plan



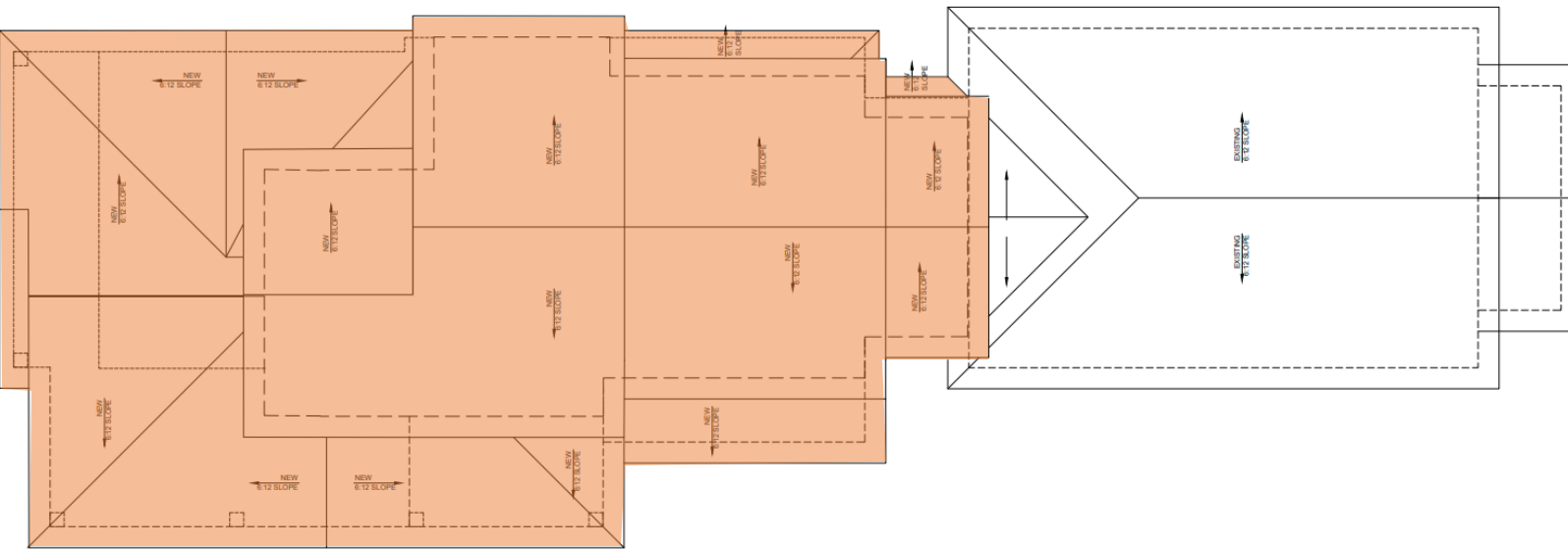
Proposed First Floor Plan

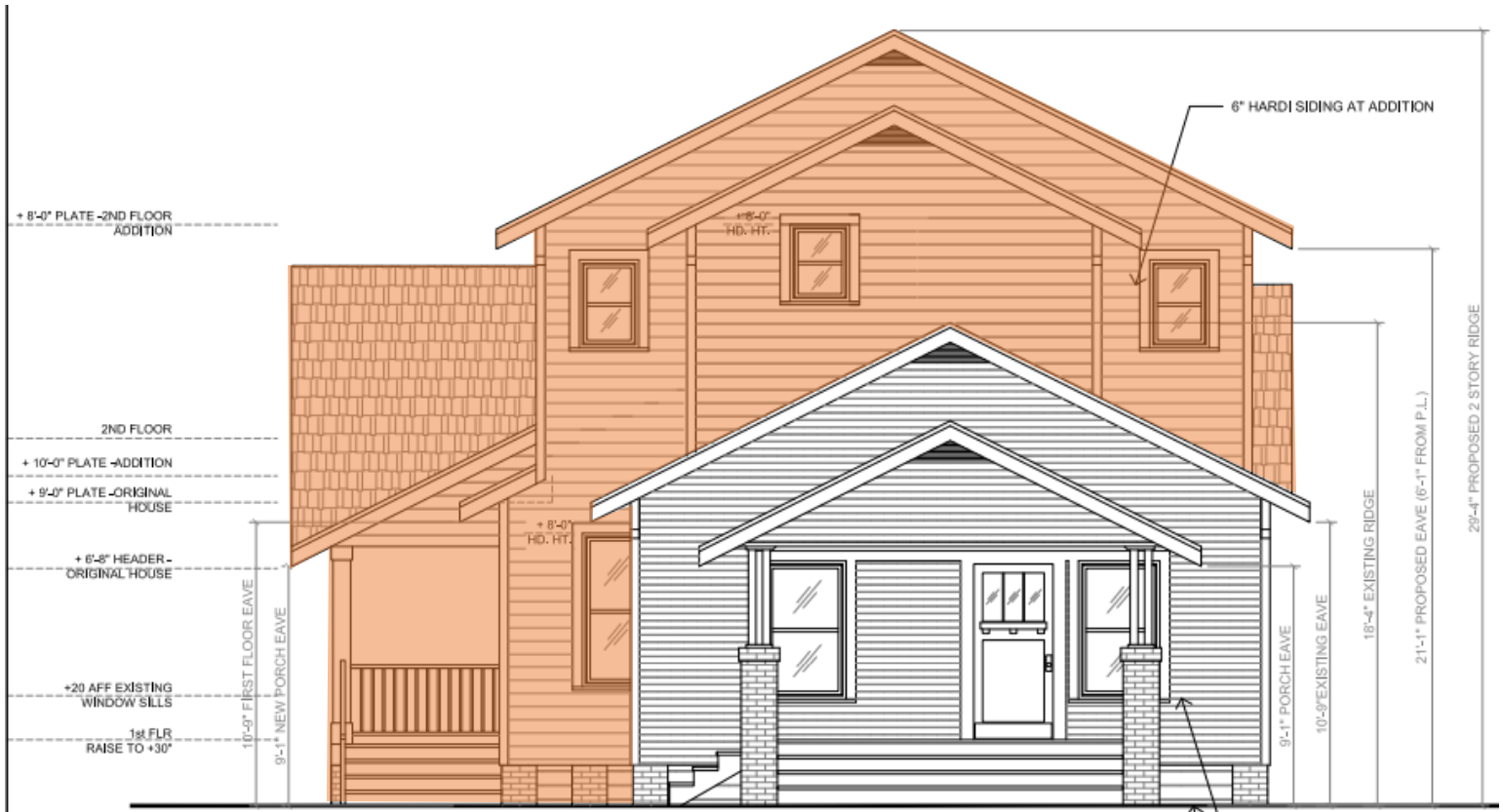
Proposed Roof Plan

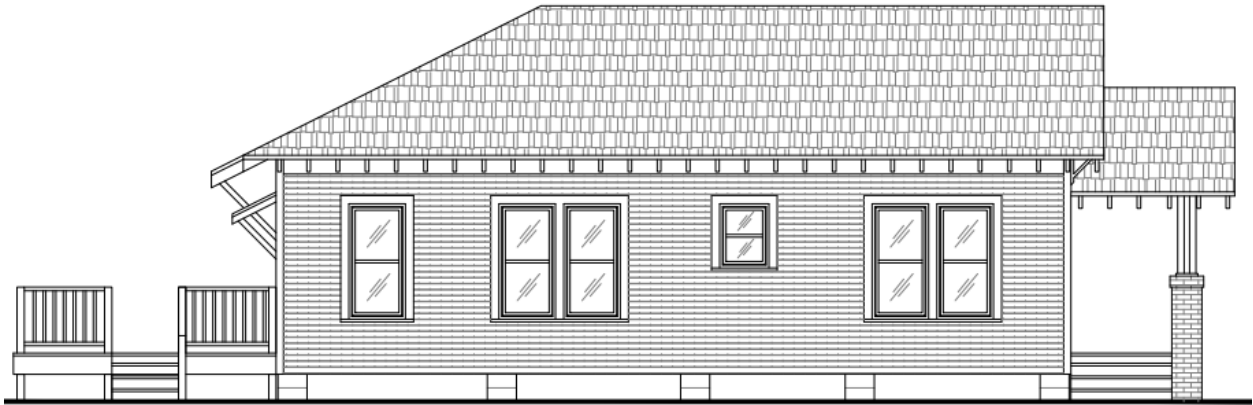

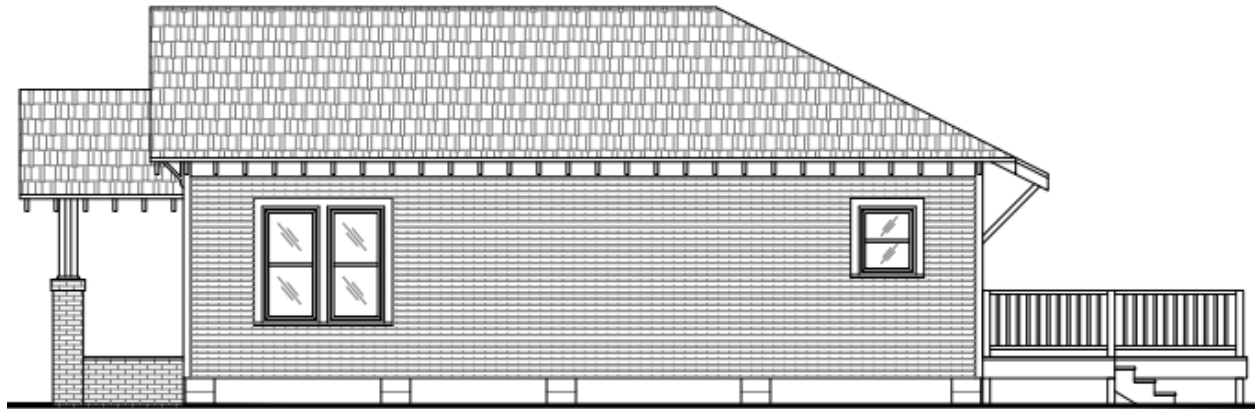
