IV. COMMENTS FROM THE PUBLIC AND THE HAHC:

Commissioner Mod echoed the announcement from Mrs. Boesel, the Mayor's Assistant for Cultural Affairs, earlier in the Commission meeting about the National Symposium for Docomomo hosted by Houston Mod.

Commissioner Cosgrove requested the status and results of any decisions made by Planning Commission concerning appeals from the Houston Archeological and Historical Commission from last month. Diana DuCroz commented that no appeals were presented; of the 5 denied projects at the January meeting of the Houston Archaeological and Historical Commission, 4 were redesigned and approved at today's meeting.

Commissioner Mod stated the Astrodome was listed in the National Register in January. The final nomination has been ordered and Houston Mod will assist with technical errors in preparation of the city landmark designation if needed.
